The Stewards, having received a report with photo evidence attached from the FIA Deputy Technical Delegate, have considered the following matter and determine the following:

Facts The driver of Car No. 34 was not correctly wearing the required safety clothing (*balaclava outside the racing suit*) at the stop control zone at the end of SS13 (Cala Flumini 1).

Offence Breach of Appendix L, Chapter III, Art. 2 of the 2024 FIA International Sporting Code and Art. 53.1 of the 2024 FIA WRC Sporting Regulations.

Decision **Fine of € 200** on the driver ROBERTO DAPRÀ

In accordance with Art. 12.8 of the 2024 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason The crew was informed accordingly by the Stewards and was given the possibility, if they wished, to bring forward any representations other than having forgotten to wear the safety equipment correctly as per the regulations.

The crew confirmed that they did not want to make any further representations.

The FIA Deputy Technical Delegate reported that the Driver of Car No. 34 (Mr. ROBERTO DAPRÀ) had his balaclava outside the racing suit at the stop control zone at the end of SS13 (Cala Flumini 1). This was substantiated by photographic evidence.

Whenever a car is in motion on a special stage and until the stop control, the crew must wear homologated crash helmets, all required safety clothing and equipment in compliance with the requirements set in Appendix L, Chapter III of the 2024 FIA International Sporting Code.

Failure to comply with these requirements constitutes a breach of the regulations. The penalty imposed is proportional to the infringement and in line with previous precedents.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2024 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
