**DISQUALIFICATION FROM THE COMPETITION, suspended until the end of the DKM-Season and an airtight excuse to the person affected.**

Offence: Breach of Article 12.2.1.i of FIA International Sporting Code (unsportsmanlike behavior)

Applied Article: Punishment in application of Art. 12.3 and 12.4 FIA International Sporting Code


Reason: The Stewards consider it proven that it would have been possible for the Drivers named above to avoid the incident. In this respect, it was to be punished accordingly.


