The Super Special Stage can be carried out at the beginning and/or at the end of each leg of the rally.

### 3.2 Eligible Entrants and Drivers

For each car, a crew of two people must be entered, both considered Drivers (1<sup>st</sup> and 2<sup>nd</sup> Driver), and therefore holders of a valid Driver's license, with the limitations indicated below.

Drivers with a NAZ C Circuit/Road or NAZ D Circuit/Road license cannot participate in rallies entered in the International Calendar.

FOREIGN Entrants and Drivers who wish to participate in a national or international Competition organized in Italy (the events must be entered in the national or international calendar) must have the authorization of their own ASN (Foreign Sporting Authority which issued the license). The authorization must be presented to the Organizer who has the obligation to request it. The absence of this document, if brought to the knowledge of ACI Sport or the FIA, constitutes a violation according to articles 2.3.10 and 3.9.4 of the International Sporting Code, and involves a sanction.

- Entrants and Drivers holders of a license issued by ACI;
- Entrants and Drivers holders of a license issued by foreign ASN.

### 3.3 Eligible Cars

FIA regulations apply on safety fuel cells to all cars. Historic cars are not permitted.

#### b) **CAMPIONATO ITALIANO RALLY TERRA CIRT**

The cars of the following groups compliant with the prescriptions of the App. J will be admitted: RC2N (excluding A8 and K11 cars), RGT, RC3N, RC4N, RC5N, RC6N.

The following cars will not be allowed to participate in the events: WRC, A8 and K11.

### 3.4 Entries, plates and competition numbers

#### a) **Entries**

Entries will be open from **15 June 2023**

**Entries must close by midnight on the Wednesday of the week preceding the rally.**

Entrants/Drivers with a foreign license must download the forms from the website [www.acisport.it](http://www.acisport.it) or from the Organizer's website and send them by email. These forms must be duly completed and forwarded to the Organizer, together with the Medical certificate and the authorization of the own ASN.

By the Monday preceding the rally, the Organizer must compulsorily warn the entrant of any missing or irregular documents.

Entries will not be accepted if they are not accompanied by the entry fee. Payment must be made in the ways foreseen by the Organizer.

#### b) **Plates and competition numbers**

Each registered crew will be provided, free of charge and **in accordance with Art. 11 BIS of the NG Rally**, the competition numbers and the following material:

- a competition plate to be applied to the front of the car;
- an adhesive number plate to be applied to the rear window;
- **two number holder panels measuring 67 cm long by 17 cm high to be applied on the doors;**
- **two series of numbers 20 cm high to be placed on the rear side windows;**
- a number 15 cm high, with a line width of 20 mm in black on a white background to be affixed to the front glass, co-driver side.

The cars must be presented at the scrutineering with the rally numbers and official plates applied.

Any punching will be carried out under the respective team's location in the service park, as per the current regulations.

### 3.5 Entry fee

The following Entry fee must, under pain of nullity, be paid for each car, determined in accordance with the Regulations of the Relevant sector (RdS).

In case of refusal of the optional advertising as per the following article 3.7, letter b), the amounts of the entry fees will be increased **by double of the Entry fee**. This amount can be paid by the end of the scrutineering.

### 3.6 Insurances

The Organizer fully acknowledge the fact that the RC policy, mentioned in art. 56 of the RSN, responds to the standards established by art. 124 of the insurance code, with the legal minimums, and does not release the Entrants and Drivers from any liability they may possibly incur outside the subject of the insurance and additional general and special policy conditions as published on the federation's website and which may in any case be requested to the Insurance Company.

### 3.7 Advertising

- Compulsory advertising: the advertising spaces on the panels containing the rally numbers and on the official rally plates will be reserved for the following Sponsors: **Giorgi Ufficio**.
- Optional advertising: competitors who accept the optional advertising proposed by the Organizer must reserve advertising space for a total of 1600 cm<sup>2</sup> for the following Sponsors **T.B.A. with a Bulletin**.

The Organizer reserves the right to communicate in bulletin the position that optional advertising must have on the cars. Infringements of the advertising rules will be penalized at the Stewards' discretion.

## 4. GENERAL OBLIGATIONS

### 4.1 Scrutineerings

During the Scrutineerings, the Technical Delegates will check the correct positioning and conformity of the belts and their attachments, of the seat, of the anchoring of the head retention device on the helmet, of the helmet itself and of the fireproof clothing.

#### 4.1.1 Car Marking

**The marking of the cars and spare parts required for the operation, as provided for in Art. 24 of the C.I.R.T. RdS, will be performed in the assistance area of each crew; the cars must be presented without underbody protection and with the wires passed through the special holes. The cars must be supported by stands or rigid structures.**

### 4.2 Drivers safety

- During the special stages, the drivers must obligatorily wear a fastened approved helmet and have their seat belts fastened, together with the head restraint device and related safety devices, under penalty of exclusion.
- All Drivers who are found not in compliance with international or national regulations relating to clothing/safety devices must be excluded from the event and referred to the Sporting Justice.
- Each admitted car must have a red reflecting triangle on board which, in case the car stops along the itinerary, must be placed, in a visible position, at least 50 meters behind the car.
- In the event of an accident which does not require immediate medical attention, the "OK" sign on board the car must be clearly displayed to at least the three following cars.
- Should medical intervention be necessary, the sign with the red SOS symbol on board the car must be displayed, with the rally number, if possible, at least to the three following cars.
- **The crews forced to retire will have to notify the Race Control as soon as possible by calling the phone n. 329 9243703 and pushing the appropriate button on the tracking device.**
- The Stewards will take disciplinary measures against drivers who fail to observe the provisions of this article.



- A "Tracking System" is mandatory for all the cars in the event, for exclusive use of support the Race Control, as foreseen for the NG Rally.
- Tracking BOX Deposit:  
During the scrutineerings, the crews/owners will be required to pay RDS a mandatory deposit of € 300.00 (three hundred/00 - VAT included) for each Tracking BOX collected as a guarantee of the loan for use. The deposit must be paid by the competitor/owner with a bank cheque in the name of RDS. This deposit will be returned upon return of the Tracking BOX. Failure to provide the aforementioned deposit will not allow the crew to collect the Tracking BOX necessary for participation in the event. See art. 6.5.2 of the NG.

#### 4.3 Crew Identification

Each conductor must provide two recent passport photos cm 4 x 4. During the administrative checks, the photos will be applied to the "crew identity card" which must be displayed inside the rear side window, 1<sup>st</sup> driver side, throughout the event. The identity card must be visible from the outside. Safety windows films must be transparent and colourless.

**The use of silver or colored films is authorized, on the rear side windows, the rear glass and the glass sunroof under the following conditions: the silver or colored films used on the rear side windows must be fitted with an opening with an equivalent surface the area of a circle with a diameter of 70 mm to allow the first driver to be seen from the outside, as well as the contents of the car ( Annex J Art. 253.11 which is understood to be referred to in its entirety here).**

#### 4.4 Road Book Distribution and reconnaissance with standard road cars

During reconnaissance only the crew is allowed in the car.

The organizer will have to put the Drivers in a position to be able to carry out reconnaissance in a single day in a maximum time of 12 hours. If there is a second day of reconnaissance, it must be scheduled for the weekend before the rally. The reconnaissance must be carried out, after delivery of the Road Book and the reconnaissance form, with strictly standard road cars, without any racing equipment. A maximum of three passages is admitted for each Special Stage; in FIA titled races a maximum of two passes are allowed. The "relay" cars that precede those in reconnaissance and radio connections on the reconnaissance cars are prohibited. Any reconnaissance carried out outside the established day and times will be considered a very serious infringement and will be reported to the Clerk of the Course.

#### 4.5 Test with rally cars (shakedown)

The following road **Fermignano (PU), gravel, for a length of km 2.14** will be available for competitors from **11.00 to 13.00 for 4 WD cars and from 13.30 to 16.00 for 2 WD cars** on **15 July 2023** to carry out the tests with the rally cars.

The shakedown can be purchased before the closing of entries and can be paid for in the manner provided by the Organizer.

Failure to pay will not allow participation in the shakedown. The Organizer will draw up a list of those who will be authorized to participate.

#### CAMPIONATO ITALIANO RALLY TERRA:

- The shakedown will be foreseen for the cars driven by Priority Drivers and for the cars of the Super 2000 and R5 classes. Entry fee **€ 155.00 + 22% VAT**.

Or:

- The shakedown will be foreseen for all cars. Entry fee (Max € 100.00).

Drivers who do not belong to the priority lists and those who participate with cars other than Super 2000 and R5 have the right to carry out tests with racing cars. In this case the Entry fee may be increased up to € 155.00.

#### 4.6 Respect of the National Rules "Codice della Strada"

Along the itinerary open to road traffic, the crews must behave in compliance with the rules of the National "Codice della Strada" and with all the current traffic regulations, including the municipal regulations and any special ordinances of the Urban Police of the localities crossed.



Crews failing to complying will undergo disciplinary measures as per art. 1.17 of the NG Rally.

#### **4.7 Service**

Assistance is defined as any intervention, work and refueling carried out on a racing car. Assistance is also considered the presence, within one kilometer of the competing car, of personnel or any means of transport belonging to the competitor or to the technical assistance team of the crew (subject to the exceptions provided for in art. 13.2 of the NG Rally) and the abandonment for any reason of the itinerary indicated in the Road Book.

During the event, the assistance must be carried out exclusively within the service parks. Assistance outside the service parks, ascertained by the Marshals, will result in exclusion from the event and, should this be valid for a national title, the loss of the points acquired up to this event.

**Vehicles must circulate at walking pace within the service park (maximum speed allowed 30 km/h).**

**All assistance vehicles, for reasons of order and management of the services parks, must enter the assistance park on Friday 14 July 2023 from 18.00 to 20.00 or Saturday 15 July 2023 from 06.30 to 08.00 and they will have to comply with the provisions of the Marshals. Only vehicles with the "Assistance" plate affixed to the front glass will be able to enter the park; for the access of additional vehicles, the "Auxiliary" plates will be on sale at the Rally Secretariat at a cost of € 100.00 + VAT each.**

**It is forbidden to drill holes on the surface in the entire Service Park area; when an assistance team leaves its space at the end of the event or during it, the Marshals will check that the area has been cleared of waste and that no holes have been drilled. Any violation will be sanctioned by the Stewards. The spaces within the service park (Technical Area and Work Area) will be assigned in accordance with Art. 13.4 of the NG Rally.**

**Competitors who do not communicate the characteristics of their Technical Area in the service park by Monday 10 July 2023 will only use a maximum area of 60 m<sup>2</sup>, positioned at the discretion of the organizers within the service park, without the possibility of joining other areas. Any need for more space for the technical area must be communicated by the competitors by Monday 10 July 2023 and will be made available for a fee, as required by Art. 13.4 of the NG Rally, at a cost of € 12.00 + VAT per m<sup>2</sup>.**

**Any non-compliance with the above will be sanctioned in accordance with the provisions of Art. 13.4 of the NG Rally.**

#### **4.8 Number of Tyres and Tyres Marking for CIRA and CIRT**

All Competitors at the exit of the starting TC in the event that the first Special Stage is not preceded by the Service Park or at the exit of each Service Park and each Remote Service, must provide the Technical Delegates with the list of tire barcodes on board your vehicle.

The list of barcodes of the tires on board the car must also include, in the appropriate section of the form, the codes already indicated above, up to the maximum number of tires permitted.

In the event that the first day of competition includes only a Super Special Stage, not followed by other special stages, it will not be necessary to provide the Technical Delegates, using the appropriate form, with the list of barcodes of the tires on board their car.

The count of the maximum number of tires that can be used starts from the moment in which the form containing the barcodes is first delivered to the Technical Delegates and in any case those for the shake down and those for the super special stage, if foreseen in the ways indicated above.

The Technical Delegates will be able to check, at any time during the event, the correspondence between the tires declared and those actually on board, also by means of identification systems additional to the use of barcodes.

It is the Competitor's responsibility to ensure the correct supply of the barcodes of the tires to be used. Competitors who are accused of errors and/or discrepancies will be sanctioned with the exclusion of their Drivers from the event.

#### **b) CIRT**

It will be possible to use a maximum of: 10 tyres.

The number of usable tyres does not include those for the Shakedown.

**Tire changes are permitted in all service parks. All drivers are reminded that the delivery of the first tire module must take place at TC 0d - Fermignano - IMAB Pisacane - Service OUT.**

#### **4.9 Refuelling**

The competitors use only the official fuel (mono-fuel) that will be distributed to them, for a fee, within the refueling areas by the company refueling areas by the company **Panta Distribuzione S.p.A.** Competitors who participate with diesel and LPG vehicles will have to refuel these vehicles during the event, must take place within the refueling area where the competitors will refuel with their own means. GPL cars will also be able to refuel in public service areas (fuel stations), which the organizer may have identified along the itinerary and communicated to the competitors.

In the rallies of the Campionato Italiano Rally Terra also valid for the Challenge Raceday, the compulsory use of the official fuel (mono-fuel) is foreseen only for the competitors participating in the Campionato Italiano Rally Terra who want to acquire the relative score. In this regard, they must effectively use the fuel in question during the event.

**The fuel distribution for the shakedown will take place on Saturday 15 July 2023 from 08.30 to 16.00 in the refueling area of the Service Park.**

**All competitors are reminded that, in compliance with Art. 22.1 of the CIRT RdS it is mandatory to carry out the first refueling (ZR1).**

**4.10 Mudflaps** Mudflaps must be used on all wheels in rallies on gravel.

## **5. RUNNING**

The start and finish of the event must be foreseen from inside the service park, alternatively, in a well-defined and protected area.

#### **5.1 Pre-Start Parc Fermé** (if provided)

The crews will have to drive or have their cars driven to the pre-start Parc Fermé at **Not Applicable**.

#### **5.2 Starting List**

For the assignment of the starting list, the Organizer must comply with the provisions of the RdS.

**5.3 Timing (Special Stages)** The detection of the time will be carried out to the tenth of a second.

**5.4 Official Time** The events' official time is the time signal **GPS - UTC+2 (CEST)**.

#### **5.5 Final Parc Fermé**

At the end of the event, the cars must be taken to the parc fermé in **Borgo Mercatale, Urbino (PU)** and parked there until the deadline for submitting complaints expires or until the parc fermé is opened by the Marshals.

Failure or late delivery of the cars to the park fermé or their removal from it without authorization will result in a sanction which may go as far as exclusion from the classification.

The park fermé, after its opening, will/will not be supervised by the Organizer.

## **7. PROTESTS AND APPEALS**

#### **7.1 Protests**

Any protests must be lodged according and within the terms provided in the NG.

The security deposit to be paid for each claim will be € 350.00. If the protest is of a technical nature, a deposit must also be paid for disassembly and assembly costs, the amount of which will be decided without appeal by the Stewards, after consulting the Technical Delegate, on the basis of the Rates indicated in the RSN. The decisions communicated by posting on the Official Notice Board will have the value of notification.

## 7.2 Appeals

Any appeals must be lodged according and within the terms provided in the NG. The security deposit to be paid for each appeal will be € 1500.00.

## 8. CLASSIFICATIONS

The following classifications will be drawn up:

General; Group; Class; Female; Under 25; Over 55 (CIRA e CIRT); Special **“Downhill Trophy” - assigned to the crew, among those who started with RC4N Group cars, who will have set the best time in the test segment, entirely downhill, consisting of the final 4.34 km of the SS Colondello. For each crew will be considered, for the purposes of this ranking, the best time among those signed in the repetitions of the event. All crews who have completed at least one passage on the SS Colondello will compete for the classification; crews excluded from the general classification of the event due to disciplinary and/or technical measures will not be considered for the purposes of this classification.**

## 9. PRIZES

The trophies cannot be combined with each other (relative to groups and classes). Therefore only the highest trophy should be awarded. This rule does not apply to the trophies of the absolute classification which are therefore cumulative.

### 9.1 Trophies

Trophies will be positioned in order to be collected directly by the awarded drivers.

- Overall Classification **from 1<sup>st</sup> al 10<sup>th</sup> overall**
- All other classifications: to the first 3 classified crews
- To the first three classified in each class of the Racing Start
- Teams: **1<sup>st</sup> Team classified**
- Team to which the absolute winner of the event belongs (in the event that the driver has indicated it in the entry form and as long as he holds an ACI license. Or to the Entrant, only if a Legal Person)
- Other Trophies **1<sup>st</sup> classified Downhill Trophy**

The prizes of at least the first three crews of the absolute classification and of the Tuner/Renter of the first classified car of the event must be done on the podium immediately after the finish.
