The Stewards, having received a Report from the Clerk of the Course with documentary evidence attached, summoned (Doc 4.6) and heard the team coordinator Mr. Jiri SVEC, have considered the following matter and determine the following:

Fact: Failure by the crew addressed above to activate the OK display on the FIA Safety tracking device within one minute after stopping on SS 2 (at 10:08:02) on Saturday, October 7th, 2023.

Offence: Breach of Art. 53.3.3 of the 2023 FIA RRSR

Decision: Driver Ola NORE JR and Co-driver Rune EILERTSEN shall be jointly and severally liable to pay a **fine of 250 EUR**.

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entail suspension during the period the fine remains unpaid.

Reason: The competitor was informed accordingly by the Stewards and was given the possibility to bring forward any representations other than that the alleged infringements were caused by forgetting.

Representative of the crew explained that crew members forgot to press the OK button in time.

The data provided by the FIA Safety tracking system showed that the Car No 23 stopped on the SS 2 at 10:08:02. The OK button was pressed at 10:10:55. The reaction time was therefore 00:02:53.


The Stewards conclude that a breach of the above regulations occurred and that the penalty imposed is in line with previous precedents.

The decision is based on the FIA International Sporting Code Art. 11.9.1, Art. 11.9.3.a, Art. 11.9.3 f and Art. 12.4.1.c.




