The Stewards, having received a photo from the FIA Technical Delegate, summoned (Summons No 4, Doc 4.4) the competitor, have considered the following matter, and determine the following:

Fact: At the Stop Control zone at the end of SS7, it was found that the FHR systems of both crew members were not worn correctly.

Offence: Breach of Art. 3. 2 - Chapter III of Appendix L of the FIA 2023 ISC
Breach of Art. 53.1 of the FIA 2023 RRSR

Decision:

- **To impose a fine penalty of 500 EUR on the Driver**
- **To impose a fine penalty of 500 EUR on the Co - driver**

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entail suspension during the period the fine remains unpaid.

Reason: The competitor was informed accordingly by the Stewards and was given the possibility to bring forward any representations other than that the alleged infringements were caused by forgetting.

The competitor did not want to come to the hearing.

Whenever a car is in motion on any type of special stage and until the stop control, the crew must wear homologated crash helmets, all required safety clothing and equipment in compliance with Appendix L Chapter III - Drivers' Equipment as intended by the equipment manufacturer and their safety belts correctly fastened (Art. 53.1 FIA 2023 RRSR).


The photo clearly shows that the FHR systems of both crew members are not worn as required by Art. 3. 2 - Chapter III of Appendix L of the FIA 2023 ISC and Art. 53.1 FIA 2023 RRSR. FHR system is a very important safety item.

The decision is based on the FIA International Sporting Code Art. 11.9.1, Art. 11.9.3.a, Art. 11.9.3 f and Art. 12.4.1.c.


