The Stewards, having not received any official withdrawal information from the permanent individual competitor VMV Racing regarding the driver #13 Viktor VRANCKX that they would not be present for the FIA European RX2e Rallycross Championship, R4 Belgium, have considered the following matter, determine the following:

Competitor: VMV Racing

Time (fact): 04/08/23 11:30 after administrative checks

Session: Entry registration

Fact: Failure to participate

Offence: Breach of Article 8.3 of the Sporting Regulations of the FIA European RX2e Championship

Decision: 5000, - Euro fine in accordance with the FIA International Sporting Code Article 12.4.1.c. Of that 2500 Euro is suspended pending presentation at the next competition and in accordance with the FIA International Sporting Code Articles 11.9.3.g and 12.4.6

Reason: The stewards were advised that the competitor/driver failed to present themselves to administrative checking and there was no communication presented in regard to any inability to participate

The Competitor is responsible to the FIA to ensure that their driver takes to the grid for each Competition of the Championship. Any failure to participate will result in a penalty, except in cases of Force Majeure

Reason for the suspension of the penalty (part):

The penalty assessed is in keeping with past precedents in this championship however with one remaining competition when the competitor/driver presents themselves to that event then the fine is effectively reduced to 2500 Euros.


Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.

Fines: In accordance with Article 12.8 of the FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail Suspension during the period a fine remains unpaid.
