The Stewards, having received a report from the FIA Judge of Fact, regarding an incident between cars #7 Patrick O'DONOVAN and #22 Máté BENYÓ in H3 R3 of the FIA European RX1 Rallycross Championship, after having examined the video evidence MVRC, after having, summoned and heard from the drivers Patrick O'DONOVAN, Máté BENYÓ and team representatives having examined the video evidence MVRC, have considered the following matter, determine the following:

**Driver and car No:** #7 Patrick O'DONOVAN  
**Competitor:** Patrick O'Donovan  
**Time (fact):** 10:57  
**Session:** H4 R3  
**Fact:** Causing a collision  
**Offence:** As defined in article 4 of the General Prescriptions applicable to International Rallycross Competitions and to the FIA Rallycross Championships  
**Decision:** Reprimand  
**Reason:** The steward's reviewed the MVRC evidence and on board footage having summoned and heard from the drivers and team representatives find that #7 on Lap 5 leading into T2 made right rear contact with #22 and was responsible for the incident

Competitors are reminded that accumulation of Reprimands will result in an automatic deduction of championship points in accordance with Article 17.23 of the Sporting Regulations of the FIA European Rallycross Championship.

The stewards for this incident impose a reprimand for unsporting behaviour


