The Stewards, having received a report from the Race Director & FIA Judge of Fact, regarding an incident between cars #30 Nils VOLLAND and #6 Damian LITWINOWICZ in H1 R3 of the FIA European RX3 Rallycross Championship, after having, summoned both drivers and their team manager, then heard the driver #30 Nils VOLLAND (summons No.02), have considered the following matter, determine the following after having examined the video evidence MVRC and onboard, determine the following:

**Driver and car No:** #30 Nils VOLLAND  
**Competitor:** Volland Racing  
**Time (fact):** 13:33  
**Session:** H1 R3  
**Fact:** Not respecting the car on his right into T1  
**Offence:** Breach of Appendix L, Chapter V 2.b of the FIA International Sporting Code  
**Decision:** Reprimand  
**Reason:** The stewards having summoned both drivers and competitor were advised by the CLO that the competitor had advised that only #30 needed to attend. Having reviewed the MVRC evidence and #30 onboard determine that #30 turned too early into T1 not respecting #6 on his right and made contact.  
Competitors are reminded that accumulation of Reprimands will result in an automatic deduction of championship points in accordance with Article 17.23 of the Sporting Regulations of the FIA European Rallycross Championship.  
The stewards for this incident impose a reprimand for unsporting behaviour.


