The Stewards having been advised that #13 Viktor VRANCKX will not participate in the Event and having been forwarded an email from the Team Manager Bert Vranckx VMV Racing to the Championship Coordinator (5<sup>th</sup> August at 13:23) are notified that #13 would not be present at R5; having considered the matter, determine the following:

**Competitor:** VMV Racing

**Time** (fact): 05/08/23 13:23

**Session:** Entry registration

**Fact:** Failure to participate

Offence: Breach of Article 8.3 of the Sporting Regulations of the FIA European RX2e

Championship

**Decision:** 2,500 Euro Fine which is invoked from the suspensive element of Decision No.02 from

World Rallycross of Benelux

**Reason:** The Stewards were advised that there had been discussion and exchange via whatsapp

and telephone calls between the competitor with both the Promoter and the FIA Sporting Delegate prior to R4 Belgium however no formal notification had been received in line with the prescribed procedures. The email of 5<sup>th</sup> August from the Competitor explained that they considered this discussion sufficient to notify of the withdrawal from the

remainder of the Championship but this was not the case.

Decision 2 from World Rallycross of Benelux imposed a 5,000 Euro fine which had 2,500 suspended subject to the Competitor presenting themselves for the World Rallycross of Germany which they have failed to do. It is the Competitors obligation as a Permanent Competitor to take to the grid as required by Article 8.3 of the Sporting Regulations of the FIA European RX2e Championship. There is no further order made in this respect.

"The Competitor has a responsibility vis-à-vis the FIA to ensure that their Driver takes to the grid for each Competition of the Championship. Any failure to participate may result in a penalty, except in cases of Force Majeure.."

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.

Fines: In accordance with Article 12.8 of the FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail Suspension during the period a fine remains unpaid.
