The Stewards, having received a report from the FIA Technical Delegate (Document no 6.3.7), after having examined the report concerning driver #36 Guerlain CHICHERIT in the FIA World Rallycross Championship, have considered the following matter, determine the following:

Driver and car No: #36 Guerlain CHICHERIT
Competitor: Special One Racing
Time (fact): 16.06.23 17:35
Session: Scrutineering – Tyre registration
Fact: Breach of Article 10.2.2 Sporting regulations of the FIA World Rallycross Championship – Late arrival for tyre registration
Offence: Not respecting the time schedule – Supplementary regulations Part 2
Decision: 400, - Euro penalty. In accordance with the FIA International Sporting Code Article. 11.9.3.f and 12.4.1.c
Reason: Part 2 of the Supplementary Regulations for this Event (World RX of Norway), Scrutineering Time Schedule for Tyre Registration requires that 'Tyre registration sheets must be sent to the following address: wrx.technical@fia.com Friday 16/06/23 latest at 16:30 Saturday, 17/06/23 from 18:00 to 19:00. (for tyres to be used on Sunday 18/06/23 only)

The Stewards are advised that the tyre registration sheet for #36 was sent at 16:54. 'Outside of these aforementioned time slots, tyres registrations can be allowed only with the permission of the FIA technical delegate' which has subsequently been provided. The stewards urge all participants to ensure that they are available to undertake the necessary presentation within the time scales which is also respectful to the officials undertaking the role accordingly the stewards impose a fine to #36 of 400 Euros for failing to adhere to the time schedule.

Fines: In accordance with Article 12.8 of the FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail Suspension during the period a fine remains unpaid.
