Following postponement of the FIA World Rallycross Championship (RX1e) Round six (World RX of Germany) the Stewards were asked by the FIA Sporting Manager to consider permitting the following drivers to transfer their entry from RX1e to RX2e for this Event; Klara ANDERSSON and Niclas GRÖNHOLM.

**Decision :** The Stewards have taken into consideration that the drivers referenced above had entered into the Event in accordance with Article 3.11.2 of the FIA International Sporting Code and amend the Supplementary Regulations in accordance with 11.9.3.b. of the FIA International Sporting Code. In accordance with Article 7.4 of the Sporting Regulations for the FIA European RX2e Championship the Stewards have allowed the Competitors to transfer their entries for this event only to the RX2e Competition on this basis: these drivers will not score Championship points which would otherwise be awarded in accordance with Articles 15.6 and 15.8 of the RX2e Sporting Regulations. They will also not qualify for the Competition cash prizes as set out in Article 19.5 of the RX2e Sporting Regulations. In addition, in consideration of Article 10.2.3. RX2e Sporting Regulations (dry weather tyres), the Stewards have also decided to reduce the permitted tyres for each driver referenced above in this respect to 6 for this Competition. In all other respects the FIA European RX2e Championship Sporting Regulations apply as appropriate.

**Reason:** In consultation with the Competitors of those drivers referenced above and in the interest of the Event and the fans the Stewards considered that all possibilities should be taken to facilitate the participation of the drivers referenced above in RX2e and to ensure sporting fairness of the championship.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
