The Stewards, having received a report from the FIA Judge of Fact, regarding an incident between #88 Ole Henry STEINSHOLT and #5 Pablo SUÁREZ in the FIA European RX2e Rallycross Championship in H2 R2, having summoned and heard from the driver and team representative #88 Ole Henry STEINSHOLT the driver #5 Pablo SUÁREZ and team representative Janina Gonzalez along with Daniel Medino (Summons No 03), after having examined the video evidence, have considered the matter determine the following:

**Driver and car No:** #88 Ole Henry STEINSHOLT  
**Competitor:** Ole Henry Steinsholt  
**Time (fact):** 15:51  
**Session:** H2 R2  
**Fact:** Pushing and gaining a lasting advantage  
**Offence:** Breach of the rules as defined in article 12.2.1.j of the FIA International Sporting Code, and specifically in violation of Appendix L, Chapter V 2(b)  
**Decision:** Disqualification from the H2 R2 (FIA International Sporting Code 12.4.1.m)  
**Reason:** After having reviewed the MVRC evidence of the incident the stewards find that #88 missed his braking zone into T1 making hard contact and the car riding up the rear of #5. At the beginning of the hearing the driver of #88 admitted that he was wholly and predominantly at fault for the incident as he braked too late and moved to his right side and made contact with #5. The stewards thanked the driver for his honesty and his conduct during the hearing. The stewards for this incident impose a disqualification from the H2

Competitors are reminded that in accordance with Article 12.2.4 of the FIA International Sporting Code and Article 17.3 of the Sporting Regulations of FIA World/European Rallycross Championship the above penalty is not susceptible to appeal.
