Decision:	The cars are allowed to start R4 in Sweden
Reason:	In consideration of the suspended disqualification (until Germany) taken in Norway regarding #30 Nils Volland the stewards also grant a waiver for R4 FIA European Rallycross Championship (RX3) to the following cars which were identified during pre-event scrutineering as in attendance at this Event; #6 Damian LITWINOWICZ, #8 Espen ISAKSÆTRE, #18 Zsolt Szíjj JOLLY & #99 João RIBEIRO. As referenced in Decision No. 33 the sheet must be 'steel' and must be replaced with steel in order to conform to the current regulations for R5 Germany.
	Appendix J – Article 279 states: <b>10.3.11 Floor / Rear part</b> The rear part of the floor may be modified by removing the spare wheel housing and adding a steel sheet in its place.

The size of the piece is 740mm x 680mm. Thickness is 6,50mm.
