The Stewards, having received a report from the FIA Technical Delegate (document 6.3.4), and accompanied by a report from the supplier QEV, having examined the report, determine the following:

Driver and car No: #68 Niclas GRÖNHOLM

Competitor: Construction Equipment Dealer Team

Time (fact): 15:00

Fact: Change of front inverter

Offence: Breach of 10.3.2 of the Sporting Regulations of the FIA World Rallycross Championship

Decision: Joker granted in accordance with Article 10.3.2

Reason: **10.3 RESS, motors and inverters**

10.3.2 Electric motors, RESS and inverters will be sealed. A Driver may use up to 2 (two) electric motors (or sets of seals), 1 (one) battery pack (or set of seals) and 2 (two) inverters (or sets of seals) in a Championship season. Electric motors, RESS and inverters will be sealed.

The penalty for any breach of this rule, the use of more components than allowed in the Championship year, will be the deduction of 15 (fifteen) Championship points for each offence. These points will be deducted from the Championship point total scored by the Driver and Team. In exceptional circumstances (accident generating serious damage to the components or technical problem not imputable to the Competitor), jokers may be granted at the discretion of the FIA stewards following the technical report from the appointed supplier and the FIA technical delegate.

The stewards reviewed the report from the FIA Technical Delegate in addition to the report from the supplier QEV who explained that during the last lap of Heat 3, Race 2 #68 slowed down. After checking the data an over current error has been reported by the front inverter, after power cycle and spin check on stands inverter was working but it is not possible to check if under load is also ok. Therefore due to reliability the Stewards agreed that a joker is granted in accordance with Article 10.3.2 of the Sporting regulations of the FIA World Rallycross Championship.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
