The Stewards, having received a report from the FIA Judge of Fact, regarding an incident between cars #7 Patrick O'DONOVAN, #33 Ulrik LINNEMANN and #1 Anton MARKLUND during the Final of the FIA European Rallycross Championship RX1, after having, summoned and heard the driver Patrick O'DONOVAN and team representative David Mansfield, Ulrik LINNEMANN and team representative Magnus Linnemann, Anton MARKLUND and team representative Aleksi Koskinen (summons No 01), after having examined the video evidence MVRC, have considered the matter, determine the following:

Offence:	Breach of the rules as defined in article 12.2.1.j of the FIA International Sporting Code, and specifically in violation of Appendix L, Chapter V 2(b)
Decision:	Reprimand
Reason:	<p>The Steward's find that after the start of the final #7 caused by his contact a chain reaction with #33 and #1 causing a disadvantage for both cars. On reviewing the MVRC evidence the stewards find that #1 wheels were turned in the direction of the main track not to the direction of joker but due to the push from #33 he had to go into the joker. The stewards for this incident impose a reprimand for unsporting behaviour</p> <p>The stewards also request that the driver has a meeting with the FIA Race Director and the Driver advisor before his next event regarding driving standards generally</p> <p>Competitors are reminded that accumulation of Reprimands will result in an automatic deduction of championship points in accordance with Article 17.23 of the Sporting Regulations of the FIA World Rallycross regulations</p>

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
