#### 3.0 Update SR 14

- Safety trackers will be installed, by a technician in service before TCO, in all competing cars, where they are to remain for the duration of the event.
- Competitors are responsible for the safe keeping and safe return of the device while it is in their possession, otherwise they will be invoiced for the full replacement cost of the device.
- For competitors who complete the event, the tracker will be removed by a technician at TC7A entering the last service of the event in the Service Park on Saturday 17 August 2024.
- For any competitor who fails to finish, the tracker must be returned to Rally Office located in Modern Tyres, Carnbane Industrial Estate, Newry by 20:00 Saturday 17 August 2024, in good condition.
- Interference, tampering, removal or adjustment of any sort in relation to the use of safety trackers will be referred to the Stewards for deliberation and possible penalties which may include disqualification from the event.

## 4.0 Paperwork

All event decals for the rally car, a Map Book, Road Book, Timecards and identification decal for your Recce vehicle will be supplied by the Organisers. These can be collected from the Rally Office located in the Modern Tyres Depot, Carnbane Industrial Park, Newry prior to commencing your reconnaissance. The Rally Office will be open as follows:

Sunday 11 August 2024 08:00 to 11:00 hours
Thursday 15 August 2024 18:00 to 20:00 hours
Friday 16 August 2022 08:00 to 21:00 hours

Competitors are reminded that they must have their competition licence available for inspection upon request by an event Official.

*No licence application will be permitted on the day.* Any non-production of a licence must be accompanied by an email from Motorsport UK or MSI and will be referred to the Motorsport UK Steward of the event.

#### 5.0 Reconnaissance

With regard to Reconnaissance competitors are reminded that they are only permitted a maximum of TWO passes through each special stage (special stages run more than once are considered to be one stage) as per the following:

09:00 to 18:00 Friday 16 August 2024

#### 6.0 Service Pass & Service Crew Information

This information will be available for collection at the Service Area Entrance on Friday 16 August from 12:00 hours. Further information can be found on the Sportity App.

#### 7.0 OK/SOS Board Procedure

A reminder to all Competitors that information given to Marshals or Officials regarding display of an OK/SOS Board, must ALWAYS be FACTUAL and ACCURATE.

NO INFORMATION is better than FALSE OR INACCURATE INFORMATION – please only report what you have actually observed. If you did not see anything, say so. If you are not sure of the OK/SOS Board procedure, please re-read **SR 22 Emergency procedures on Special Stages**.

#### 8.0 Scrutiny

Crews are reminded that vehicles must be presented at Scrutineering with any in-car cameras and auxiliary lighting fitted, if such equipment is to be used on the event. Also, the driver and co-driver's race suits, helmets and FHRs must be presented with the vehicle.

## 9.0 Refuelling

Crews are reminded that no re-fuelling may take place within the Service Park SR 20. There will be a Refuel zone located immediately after the Service Out control and crews should <u>make their own</u> <u>arrangements for the manual transportation of fuel</u> to and from this location. The only exception to this is in SR Art 8.4.4 when "changing of fuel tank, changing of fuel pump, changing of fuel filter or changing of any other item of the fuel circuit" is required and under the provisions stated in the section.

All Competitors and Service Crew personnel should be familiar with the contents of the Health and Safety Guidelines for Competitors and Service Teams, which is available on the Rally Guide 2 section in the Sportity App (Service Park Risk Management).

#### 10.0 Tyres

Tyre Suppliers will be located in the Service Park. Crews should make their own arrangements for the manual transportation of tyres/wheels to and from this location.
