## Cover

Legal liability of the Insured parties for injury to third parties and damage to their property (including nervous shock or mental injury, obstruction, trespass, nuisance, interference, wrongful arrest or eviction) arising from the Insured Event and happening within the Geographical Limits during the Period of Insurance

Including legal liability arising from the supply of food or drink or promotional material merchandise or souvenirs sold or supplied in connection with the Insured Event.

## Limit of Liability

£ 100 million each occurrence for Claims happening in the Period of Insurance but in all for Claims arising from Products.

## **Principal Exclusions**

- a) The first £450 of each and every claim in respect of damage to property
- b) Hazardous and dangerous activities (except in an attempt to save human life)
- c) Damage to any road track circuit or other surface and/or any equipment or circuit furniture (hired or otherwise) used for the purpose of the Insured Event(s)
- d) Use of Pyrotechnics and Explosions
- e) Participation in actual Motor sport

Exclusion c) above shall not apply to those Insured Events which take place on any Ministry of Defence land and property; always provided that the local Association, Club or Organisation responsible undertakes a track inspection or track survey by a qualified person and a photographic and/or video record is kept of any areas of the track surface which are not in a good condition in the opinion of the person undertaking the inspection or survey, prior to any activities and commencement of the event

#### **Indemnity to Others**

#### Northern Ireland (Road Closures)

The Motorsport UK Master Policy will extend to indemnify the Department of Infrastructure; Local Councils and Government Bodies which shall include, but not be limited to, those more specifically mentioned, arising out of the use of their land in connection with the Insured Event or the giving of authority for the holding of the Insured Event.

It is further agreed that in respect of any Insured Event for which an order under the Road Race (Northern Ireland) Order 1986 is made, the Insurers will, subject to the terms, exclusions and limitation of the insurance, indemnify the Organising Club, its Official, Participants, the Crown and any servant of the Crown, the Department of Infrastructure, the Police Services of Northern Ireland and the Road Authorities concerned or any Servant of such Authority or Authorities, in accordance with (but to no greater extent than) the requirement of Article 3 Section 7 subsection A (a) of such Order. Provided always that the conduct and control of claims is vested in the Insurers.
