The Stewards, having received a report from the Technical Delegate, summoned and heard the team representative, Mr. Scoot Abraham, (Summons No. 1), have considered the following matter, determine the following:

- **Fact:** Car No. 300 left the Parc Fermé with 6 wheels (two spare wheels) and returned after the selective section 4 with only 5 wheels.
- **Offence:** Breach of Art. 50.4.1 and Art. 50.4.2 of the 2023 FIA Cross-Country Rally Sporting Regulations (FIA CCRSR)
- Decision: To levy a Fine of 250 €

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <u>https://fiafines.fia.com</u>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason: The team representative confirms that the crew has lost the tyre on SS 4 in the forest part. The crew could not find it and immediately reported it to the Technical Delegate.

According to the FIA CCRSR all parts including wheels/tyres and/or part fitted on the vehicle or the vehicle during servicing must reach the next service park. No wheel/tyre may be taken off the vehicle elsewhere than in the service parks. Obviously, car No 300 lost one wheel on the selective section. Thus, breaking the FIA CCRSR 2023.

The Stewards taking into account as a mitigating circumstance that the crew reported the missing wheel immediately to The Technical Delegate. For this reason, the Stewards opted for a lenient sentence.

The decision is based on the FIA International Sporting Code Art. 11.9.1, Art. 11.9.3 f; and Art. 12.4.1.c.

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
