The Stewards, having received a report from the FIA Technical Delegate (Doc 6.2) with photo evidence about checking tyres in the tyre marking zone following TC0, having summoned and heard the driver, have considered the following matter and determine the following:

Facts During the tyre marking following TC0 tyres of Competitor #205, driven by a Priority Driver and registered for the FIA 2024 Middle East Baja Cup, were off-road tyres and not fitted with any FIA barcode.

Offence: Breach of Art. 7 of the Supplementary Regulations, and Art. 10.10-V2 of the FIA 2024 CCRSR

Decision: To impose:

- 1) A 2 (two) hour time penalty on Competitor #205 on Stage 1.
- 2) Withdrawal of points for the FIA Middle East Baja Cup 2024 for Qatar International Baja 2024.

Reason: During the hearing, the Driver stated that during his preparation of the car to FIA standards, the requirement for tyres to have FIA barcodes had not been explained to him. He had made last minute attempts to obtain the tyres but this was impossible in the time available.

According to Art. 10.10 V2 of the FIA 2024 CCRSR and Art. 7 of the Supplementary Regulations, FIA priority drivers entered with Group Ultimate vehicles are allowed to use 10 tyres and all tyres must be fitted with FIA barcodes. These barcodes will be used to check that the same tyres remain fitted to the particular vehicle between tyre changes and that competitors are not exceeding the maximum quantities allowed.

The Stewards decision was made based on FIA 2024 ISC Art. 11.9.1, Art. 11.9.2.a, Art. 11.9.3.a, Art. 11.9.3.f, Art. 12.4.1.h and Art. 12.4.5.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2024 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.


