The Stewards, having received a report from the FIA Technical Delegate (Doc. 6.5) about final scrutineering, having summoned the Competitor, having heard the Competitor representative (Mr. Moad ARJA), having examined the different elements presented, having considered the following matter, determine the following:

- Fact:** During final scrutineering, the following items checked on car #412 were found not compliant:
- The restrictor of car #412 was found not in compliance with Art. 286A-7.11.2 of the Appendix J of the FIA 2024 ISC.
 - The inlet manifold had additional mounting bolts, therefore not in compliance with Art. 286A-7.1 of the Appendix J of the FIA 2024 ISC.

Decision: To disqualify Competitor #412 from the Qatar International Baja 2024.

Reason: During the hearing, the competitor representative admitted that the restrictor was over the permitted maximum size. He stated that the engine had been untouched by the team since it was purchased. He accepted that it was an error of the team not to have checked the restrictor size prior to this event.

The Stewards conclude that, in view of the clear provisions of the relevant regulations, it was indeed up to the Competitor to ensure that the restrictor was compliant during Qatar International Baja 2024. If the Competitor wishes, he can ask the Technical Delegate or scrutineers during the pre-event scrutineering to check the restrictor.

With regard to the additional fixings on the inlet manifold, the Stewards conclude that this is a clear breach of the requirements in Art. 286A-7.1 of the Appendix J of the FIA 2024 ISC that the engine of the reference vehicle must be kept without modification.

The Stewards decision is based on FIA 2024 ISC Art. 11.9.1, Art. 11.9.2.a, Art. 11.9.3.a, Art. 11.9.3.f and Art. 12.4.1.m

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA 2024 International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
