The Stewards, having received a report from the Technical Delegate, summoned the Competitor, have considered the following matter, determine the following:

Fact: During pre-event scrutineering of Car #254 (HERRATOR HRX-3), the competitor could not present the original FIA Technical Passport and the Safety Cage certificate.

Offence: Breach of 2023 FIA CCR SR Art. 8.3, Art. 22.2 and Art. 23.13.
Breach of 2023 International Sporting Code, Appendix J Art. 283-8.1

Decision: To impose a fine of 500 €.

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason: The competitor was informed accordingly by the Stewards and was given the possibility, if he wished, to bring forward any representations other than having forgotten to bring the original FIA Technical Passport and the Safety Cage Certificate.

The Competitor acknowledged and informed the CRO that no further information from its side to this matter can be given.

A valid FIA Technical Passport must be provided by the Competitor for each car entered, at scrutineering for each rally. According to the article 25.3.1 of the 2023 FIA Cross-Country Rally Sporting Regulations, the competitor is responsible for the technical conformity of his vehicle throughout the event and should be able to provide any related official document.

The decision is based on the FIA International Sporting Code Art. 11.9.1, art.11.9.2.a, Art. 11.9.3.a, Art. 11.9.3.f and Art 12.4.1.c.
