The Stewards, having received a report from the Clerk of the Course, having examined the evidence, having considered the following matter, determine the following:

Fact: During SS1, several competitors did not follow the official itinerary defined in the road book page 13 Box 64.

Offence: Breach of 2023 FIA Cross-Country Rally Sporting Regulations (CCRSR) Art. 14.2.1.

Decision: To impose a time penalty of 2 minutes to be applied in SS1.

Reason: The CCRSR are noticeably clear that the compulsory itinerary of the Baja is defined in the Road Book by the road direction diagrams and between the road direction diagrams, by the defined road/track if it exists.

Analyzing the evidence from the tracking system, it is obvious that cars involved left the defined road between boxes 63 and 64, cutting the corner which is clearly defined in the road book diagram on km 30,31. The diagram shows a hairpin where the crews must turn left. The tracking system shows that they went off the track approximately 20 meters before box 64.

The Stewards concluded that this is a breach of the 2023 FIA CCRSR.

Following the time penalty for a WPP, the Stewards decided for a 2-minute time penalty.

The decision is based on the 2023 FIA International Sporting Code Art. 11.9.1, art.11.9.2.a, Art. 11.9.3.a, Art. 11.9.3.f and Art 12.4.1.h.

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.

Due to the fact that this infringement involved 55 cars, the Stewards decided to have this decision valid for all cars, according to the summary attached.
