The Stewards, having received the Communication n° 11 (Doc. 3.25) from the Clerk of the Course, have considered the following matter, determine the following:

**Fact:** The publication of the provisional results was on Monday, 24<sup>th</sup>, 2023 at 20.00 hrs CET.

**Decision:** **The protest time limit for protests referring to the classification will be Tuesday, 25<sup>th</sup>, 2023 at 20.00 hrs CET**

**Reason:** Due to the fact, that the *Provisional Classification* could not be published as laid down in the Supplementary Regulations and that the publication was in fact on Monday 24<sup>th</sup> April 2023 at 20.00 hrs the Stewards extend the protest deadline to 24 hrs.

According to Art. 13.3.5 and Art. 13.3.7 of the International Sporting Code, the Stewards consider that there are circumstances that the compliance with the thirty-minute deadline after the publication of the provisional classification is impossible.

To protest the competitor must send the protest deposit of 1000€ to the relevant bank account as follows:

**The reason for the transfer must be clearly indicated.**

The decision is based on the FIA International Sporting Code Art. 11.9.1 and Art.11.9.2.a,

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
