The stewards, having received a report from the FIA Technical Delegate, summoned the above competitor's representative (Stewards Individual Communication No.1), have considered the following matter and determine the following:

Fact: Competitor No. 65 failed to submit the FIA Technical passport during pre-event scrutineering

Offence: Breach of Art. 251.2.1.8 of Appendix J of the 2025 FIA International Sporting Code.

Decision: **Fine of 500 €** on the Competitor of Car No. 65 THOMAS PAHLITZSCH

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason: The Stewards heard from the Competitor, Mr. Thomas Pahlitzsch, and from the Team Manager of car No. 65, on Friday 13rd June 2025 at 10:25.

They explained that, while preparing for the event, they noticed that the FIA Technical Passport was missing. They probably lost it during the previous event. The Team Manager then contacted the FIA Technical Department, which informed them that the FIA Technical Delegate, Mr. Emanuele Saglia, would handle the matter.

According to Article 251.2.1.8 of Appendix J of the 2025 FIA International Sporting Code, all Competitors must present the FIA technical passport during pre-event scrutineering to ensure compliance with the technical and safety standards.

This failure to submit the required document is a breach of the above-mentioned regulations which outline the obligation to provide all the documents.

The stewards, therefore, concurred that non-compliance with these regulations compromises the integrity of the scrutineering process and decides that the penalty imposed is proportional for this offence.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
