Sportska komisija / The Stewards,

nakon zaprimljene prijave od Direktora rally-a / Having received a report from Clerk of the Course:

**Činjenice/Facts:** Tijekom održavanja BI 4 SB 23 se uslijed pogrešnog skretanja na križanju te nakon određenog protoka vremena vožnje krivim putem zaustavio vožnju i vožnjom unatrag, a koja je suprotna od smjera kretanja brzinskog ispita, vratio do križanja te u pravom smjeru kretanja brzinskog ispita nastavio vožnju prema cilju. Uslijed kretanja unatrag SB 23 se mimoišao sa SB 53 koji se kretao u smjeru kretanja brzinskog ispita.

During the running of SS 4 Sno 23 made a wrong turn at the intersection and after some time driving in the wrong direction, he stopped the vehicle and reversed, which was opposite to the direction of the special stage, returned to the intersection, and then continued driving in the correct direction of the special stage towards the finish. During driving in reverse Sno 23 passed by Sno 53 who was moving in the correct direction of the special stage.

**Prekršaj/Offence:** Kršenje Članka 34.1.4. FIA RRSR 2025

Breach of Article 34.1.4. of the FIA Regional Rally Sporting Regulations 2025

**Odluka/Decision:** **Dodatnih 8 minute kazne na ostvareni vremenski rezultat, a koja će se primijeniti na VK5 te novčana kazna u iznosu od 250,00 EUR sukladno Čl. 12.4.1.h i 14.4.1.c FIA 2025 ISC SB 23 Umberto Fiorile / Isabel Forgiarini.**

**To impose a 8-minute time penalty to be applied at TC5 and fine of 250,00 EUR on the Competitor of Sno. 23 Umberto Fiorile / Isabel Forgiarini in accordance with Art. 12.4.1.h and 14.4.1.c of FIA 2025 ISC.**

Sukladno čl. 12.8 FIA ISC-a za 2025., novčane kazne moraju se platiti u roku od 48 sati od njihove obavijesti. Svako kašnjenje u plaćanju može dovesti do suspenzije tijekom razdoblja u kojem kazna ostaje neplaćena.

In accordance with Art. 12.8 of the 2025 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

**Razlog/Reason:** Obavjesni razgovor je održan u nedjelju, 23.11.2025.god. u 14:42h sa vozačem i suvozačem SB 23 uz prevoditelja. Nakon obavljenog razgovora sa SB 23 isti su izjavili kako su svjesni gore opisanog učinjenog prekršaja. Napominje se kako je vožnja u suprotnom smjeru od smjera brzinskog ispita nedopustiva, k tome i ozbiljna povreda FIA 2025 ISC i posebnog pravilnika natjecanja. Slijedom navedenog Sportska komisija izriče vremensku kaznu od dodatnih 8 minuta na ostvareni vremenski rezultat te novčanu kaznu u iznosu od 250,00 EUR.


A hearing was held on Sunday, 23th November 2025 at 14:42 hrs, attended by the driver and co-driver of Sno. 23 and translator. After the hearing the crew of Sno 23 stated that they are aware of the committed violation mentioned above. It is noted that driving in the opposite direction of the special stage is prohibited, and furthermore, a serious violation of the FIA 2025 ISC and the supplementary regulations of competition. The Steward conclude that the case presents some mitigating circumstances compared to a recent precedent. Therefore, they conclude that the time penalty of 8 minutes and fine of 250,00 EUR applied is appropriate in this case.

Posada se podsjeća kako ima pravo na apel na Odluku Sportske komisije u skladu sa Čl. 15 2025 FIA International Sporting Code i poglavlja 4. FIA Judicial and Disciplinary Rules.
