Sportska komisija / The Stewards,

nakon zaprimljene prijave od Direktora rally-a / Having received a report from Clerk of the Course:

Činjenice/Facts: Tijekom održavanja BI 3 SB 145 je uslijed gubljenja kontrole nad vozilom prepriječio je stazu te onemogućio prohodnost staze. Nakon navedenog iskazane su crvene zastave od strane sudaca dužinom cijelog brzinskog ispita. SB 65 nije usporio na tri RP te nakon zaustavljanja se polukružno okrenuo te vožnjom u suprotnom smjeru od smjera brzinskog ispita vratio na start.

During the running of SS 3 Sno 145 blocked the stage due to lost of control over the vehicle preventing the continuation of the special stage. After this, red flags were displayed by the marshals along the entire special stage. Sno 65 did not slow down on three RP and after stopping made a semicircular turn and driving in opposite direction of the direction of SS returned to the start.

Odluka/Decision: **Dodatnih 5 minute kazne na ostvareni vremenski rezultat sukladno Čl. 12.4.1.h FIA 2025 ISC SB 65 Norbert Németh / Dávid Béres, a koje će se primjeniti na VK4**

To impose a 5-minute time penalty on the Competitor of Sno. 65 Norbert Németh / Dávid Béres in accordance with Art. 12.4.1.h of FIA 2025 ISC, to be applied at TC4

Razlog/Reason: Obavjesni razgovor je održan u nedjelju, 23.11.2025.god. u 09:06h s vozačem SB 65 uz prisustvo prevoditelj. Nakon obavljenog razgovora sa Sbr 65 isti je izjavio kako nije pročitao posebni pravilnik natjecanja no da je svjestan gore opisanog učinjenog prekršaja. Napominje se kako je vožnja u suprotnom smjeru od smjera brzinskog ispita nedopustiva, k tome i ozbiljna povreda FIA 2025 ISC i posebnog pravilnika natjecanja. Uzimajući u obzir kako je

riječ o vozačima klase Rally Raid Sportska komisija slijedom navedenog SB 65 izriče vremensku kaznu od dodatne 5 minute na ostvareni vremenski rezultat.

A hearing was held on Sunday, 23th November 2025 at 09:06 hrs, attended by the driver of Sno. 65 and translator. After the hearing the crew of Sno 65 stated that they haven't read the Supplementary regulation of the competition but is aware of the committed violation mentioned above. It is noted that driving in the opposite direction of the special stage is prohibited, and furthermore, a serious violation of the FIA 2025 ISC and the supplementary regulations of competition. Considering that the crew is a part of Rally Raid class and after studying the case extensively and based on all available evidence, the Steward conclude that the case presents some mitigating circumstances compared to a recent precedent. Therefore, they conclude that the time penalty applied is appropriate in this case.
