The Stewards, having received a report N° 2 from the CoC (document nº 3.5), having examined attached report from the GPS provider, have considered the following matter, determine the following:

**Date / Time:** 01-05-2025 / 12:39 hr

**Fact:** The crew of car # 69 drove in SS 8, did not start the stage at the correct TC (reconnaissance).

**Offence:** Breach of 2025 FIA Regional Rally Sporting Regulations (RRSR) Art.ºs 34.2 and 35.4.3.

**Decision:** Fine of 100,00€.

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com> . Any delay in making payment may entail Suspension during the period a fine remains unpaid.

**Reason:** According to the 2025 FIA Regional Rally Sporting Regulations during reconnaissance the crews are only permitted to enter and leave SS through the start and finish controls. That means they can not drive in opposite direction of a SS. Obviously, the competitor was not following these regulations.

The crew were shown the evidence from the tracking device, which outlined the infringement.

The crew recognise the mistake that they made because they only recceed one day, and they used the Google application to go into that SS. They only realise that they were in the SS at the beginning because they see other competitors.

The Stewards concluded that a fine is necessary but for one offence also adequate.

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2025 FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
