The Stewards having received a report from the SS Safety officer, have examined the following matter: Before SS 7, the SS Safety officer noticed that there was no female codriver in the passenger seat, but another male person. Because of this, SS Safety officer took their time card and did not allow the crew No. 47 to start. Due to the breach of Art. 22.4 of the RRSR, the Stewards have determine the following:

Žirija je prejela poročilo s strani vodje HP, so preučili naslednjo zadevo pred štartom HP 7 je vodja HP opazil, da na sovoznikovem sedežu ni sovoznice, ampak druga oseba moškega spola. Zaradi tega je športni komisar posadki št.47 odvzel časovni karton in prepovedal štart na HP 7. Zaradi kršitve člena 22.4 RRSR in s sklepom žirije določi in ugotovili naslednje:

**Fact:** *Unpermitted codriver change.*

**Dejstvo:** Nedovoljena zamenjava sovoznika

**Offence:** *Breach of Art.22.4 of the FIA RRSR.*

**Prekršek:** Kršitev člena št.: 22.4 FIA RRSR.

**Decision:** *Disqualification and fine of 1000€ on Competitor no. 47.*

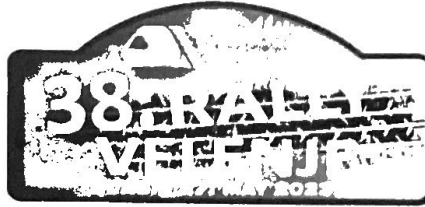
**Sklep:** Diskvalifikacija in kazen 1000€ tekmovalcu št. 47.
