Bulletins will be issued by the Organiser, up to the commencement of administrative checks with the approval of the FIA, after the administrative checks by the Stewards of the Meeting. This designation must be made before the closing date for entries for each baja, using the form on the FIA website (link above). **No changes** may be accepted **after the closing of entries** for each baja.

The FIA Baja Cups for **Teams** is reserved for **legal entities** holding a competitor's licence. Only registrations with a proof of payment of the registration fee will be accepted.

The "Service" ID bracelets will grant access to the service park and intervention to race vehicles (together with the Arm band to enter the Scrutineering) in the case laid down in the Regulations.

In the case where the ID bracelet becomes damaged, the person must get the bracelets replaced by the Organization, in exchange for the damaged one.

Checking by the organisation of this identification will be systematic at each service entrance and HQ zone, and at the entrance of the prize-giving. Presentation of the identity bracelet is compulsory each time it is requested by the

Organiser or their representatives.

Any fault remarked by a judge of fact or member of the organisation will result in a 250 € penalty.

The organiser may partially refund entry fees if a competitor cannot take part in the event due to a duly proved case of force majeure.

## Art. 5. Insurance Cover

[The supplementary regulations must give details concerning insurance cover taken out by the organisers, see FIA CCRSR Art. 15. Beneficiaries are the competitors and their service personnel registered with the organiser, the members of the organisation, its service providers and their personnel and the officials of the rally.]

#### Art. 5.1 Accident reporting

If a driver taking part in the Baja is involved in an accident in which a member of the public sustains physical injury, the driver concerned must report this to the next marshal point. If he fails in observing this rule, the Stewards may impose to the responsible crew a penalty, which may go as far as disqualification.

In case of accident in the Baja itinerary, competitor or his representative must notify in writing the Clerk of the Course, the Crew's Relation Officer or the Organizer as soon possible.

## Art. 6. Advertising and Identification

See Appendix 3 of these SR "Decals and positioning of supplementary advertising".

The organiser will provide each crew with the advertising and identification panels, which must be affixed to their vehicles in the stated positions prior to scrutineering. No modifications to the panels are allowed. However, they may be cut out if the shape of the bodywork does not allow the panels to be affixed in one piece.

- Driver's and navigator's competition licences (if one of the drivers should be the competitor, he must also hold a competitors' licence)

- Driver's and navigator's valid driving licences valid for the vehicle entered.
- Driver's and navigator's signed Driver's declaration and undertakings forms
- ASN authorisation for foreign competitors (if required)
- Completion of all details on the entry form

- FIA Technical Passport (1st page with the passport number)

The Competitor is the only responsible for the validity of the different administrative documents required to participate in the ITALIAN BAJA 2025 and in particular the validity of the driving licence, vehicle registration papers and vehicle insurance.

#### Art. 10.1 Scrutineering, venue, and time

## Art. 10.1.1 Scrutineering, mandatory documents

- Cars complete original FIA Homologation Document (if applicable)
- FIA Technical Passport
- SOS / OK board (DIN A3 format)

The installation of the tracking system and the NAV-GPS will be checked at scrutineering.

The complete original FIA homologation form / FIA Technical Passport and all other necessary certifications/documents must be available for final checks.

## Art. 10.1.2 Timetable for scrutineering

## Art. 10.2 Drivers' safety equipment

All items of clothing including helmets and FHR (Front Head Restraint) intended to be used, e.g. HANS devices, must be presented for scrutineering. They shall be checked for compliance with Appendix L, Chapter III.

Each vehicle must be equipped with a medical kit from the FIA Technical List n°83, that must be placed inside the cockpit, and a survival kit according to FIA CCRSR Appendix IV-2.1 and the defined Safety Type (see SR Art. 1.5).

#### Art. 10.3 Installation of the Safety Tracking System and Navigation System

#### Art. 10.3.1 Safety Tracking System (FIA CCRSR Art. 12.1)

All vehicles must **only** be fitted with the Safety Tracking System(s) provided by the Organiser. The instruction for the use of the Tracking System is in the Appendix 5 of these Supplementary Regulations. The rental of these units is included in the entry fee.

The installation will take place before the Scrutineering (see art. 3 of this SR). Tracking officer will collect the device from the vehicles at the Finish Parc Fermè or Service Park for retired competitors.

Manual activation of the alarm of the tracking system without a safety reason (red button) will result in the financial liability of the Competitor and may result in the disgualification of the Competitor.

#### Art. 10.3.2 Navigation System (NAV-GPS; FIA CCRSR Art. 12.2)

Competitors are obliged to be equipped with one or two Navigation System(s) (NAV-GPS) downloaded with the waypoints given by the Organiser. When a crew uses two NAV-GPS, the primary one will be identified by the supplier with a distinctive label.

Crews on ITALIAN BAJA 2025 will be equipped by the organization with ANUBE'S STELLA system that integrates the «car-to-car communication system» into the GPS. NAV/GPS devices shall be collected during the Scrutineering. Anube will collect the devices from the vehicles at the finish Parc Fermé or service park for retired competitors. The information relevant to the installation of the system on the vehicle is available on the rally website and from ANUBE.

The Competitor must contact directly ANUBE to order the support/power supply kits for this equipment. The components kit is not included in the entry fee

All competitors on the rally must have this system to pass scrutineering.

This system must be working during the running of each Stage. If it is noted that the system is not functioning due to the crew will be reported to the stewards for sanctions.

Any competitor caught by another competitor must pull overand allow themselves to be overtaken. All competitors who have received 3 requests to overtake (aural warnings) coming from the one and same competitor, in a lapse of time less than or equal to 45 seconds must, in the 60 seconds following the third request, do everything possible to allow the competitor making the request to overtake (if the terrainso allows).

The competitor who has not, in the 60 seconds following the third request to overtake, let the competitor who has made the request pass, will receive penalties as Appendix I Art. 47.3 of 2025 FIA CCRSR.

Any infringement will be penalized by the Clerk of the Course according to Appendix I – Art. 47.3 of the FIA CCRSR.

## Art. 10.3.3 Connection of the Systems (FIA CCRSR Art. 12.3)

The specifications for the standard power connector are laid down in the FIA CCRSR Appendix VI. It is the competitor's responsibility to ensure that the Safety Tracking System(s) and the NAV-GPS always remain permanently connected and switched on with the antenna connected throughout the duration of the competition.

#### Art. 10.3.4 GPS Data Logger

Vehicles selected by the FIA after the publication of the entry list may be equipped with a GPS Data Logger to monitor their performances during the event.

See FIA CCRSR Article 13.1.

#### Art. 10.4 On-Board Cameras

See FIA CCRSR Article 11.

Any competitor wishing to use an on-board camera must

- Fill out the request form available on the event website (https://www.italianbaja.it/en/for-pilots/registration/fia-event). Send the form to entry@italianbaja.com by 18 June 2025;

Team cameras must be mounted on the car at the time of scrutineering. Mountings must comply with Article 283-2 of Appendix J. All camera locations and mountings must be shown and approved at Scrutineering prior to the start of the race. After scrutineering, on-board cameras may not be moved without the approval of the scrutineers.

Crews failing to comply with these provisions will be reported to the stewards.

#### Art. 10.5 Electronic Equipment

Any radio or electronic means of communication, or any other device not expressly permitted in FIA CCRSR regulations is forbidden on board the vehicles.

#### Art. 11. Other procedures and regulations

#### Art. 11.1 Drivers' Briefing(s)

See programme (SR Art. 3)

At the first briefing of the event, the participation of at least one crew member is compulsory.

#### Art. 11.2 Pre-Start Area

- The Pre-Start Area will be set up in the same place as the Parc Fermè, competitors MUST enter the Pre-Start Area as specified in article 3 of the program in these rules.
- The Pre-start area will be controlled. Access will be limited to crew members, VIPs and media with appropriate identification/accreditation.
- Cars must be driven by one of the drivers or a team representative in the Pre-Start Area, where any kind of service is strictly prohibited; Any kind of infraction will be reported to the stewards.
- Any entry and any delay in the pre-start area outside the time window indicated in art. 3 of these regulations will be sanctioned by the C.d.C. with a fine of 100 €.

#### Art. 11.5 Finish procedures

At the end of the stage, all cars shall pass the finish ramp (Fiera – Hall 5) for interviews and then go to the Parc Fermé until its opening on the instructions of the Stewards.

- The prize-giving ceremony will take place at the "Parterre" in Hall 5 of the Fair at 22.00.
- After having parked their vehicles in the Parc Fermè at the passage of the finish line, the participants' team (Crew) must remain available by telephone (mobile phone) until the publication of the final classification.
- The podium and prize-giving will take place according to Article 3 of these regulations. The presence of both crew members is mandatory.
- The prize-giving will take place by awarding prizes to the first group and then to the first five in descending order according to the provisional overall classification.

Reservations are required no later than the closing date for entry (18 June 2025 at 06:00 pm) to the email entry@italianbaja.com.

The cost of the Water-Resistant Road Book for the Shakedown is 50€.

The cost of the Water-Resistant Road Book Kit (Leg1 and Leg2) is 200€.

#### Art. 11.9 Servicing of vehicles

#### Art. 11.9.1 Service Areas / Bivouacs

From TCPO onwards, service of a competing car may be carried out in Service Areas (Service Parks and Bivouacs) and road sections as permitted under the FIA CCRSR.

The speed of vehicles in the service parks/bivouacs may not exceed 30kph

All the Teams which have to go to the own service area have to go before in the Service Accreditation Centre (SAC). **GPS POINT:** N 45°56.836' – E 12°39.301'

#### FOR THE TRUCKS (over 3500kg):

Entry is ONLY permitted on Wednesday 02 July from 09.00 to 13.00 from the south gate (N 45° 56.853' – E 12° 39.230')

#### FOR THE SERVICE VEHICLES (less than 3500kg):

Entry is permitted on Wednesday 02 July from 13.00 to 21.00 and Thursday 03 July from 08:00 to 14:00 from the south gate (N 45° 56.853' – E 12° 39.230')


SAC will be open on Wednesday 02 July from 09:00 to 21:00 and Thursday 03 July from 08:00 to 14:00 (only for the "Service Vehicles"), and there will receive the service plates and instructions to follow for the own service area.

All the Teams will be placed by the Organizer in the Service Areas.

Once positioned, only the service or passenger transport vehicles equipped with a pass (Service, Team Manager) will be able to enter and exit the service park. The rest of the vehicles will not be able to leave the Service Park until the end of the event.




#### "TRUCK" Plate:

- Vehicles over 3500kg.
- These vehicles can enter the service park ONLY on Wednesday, 02 July from 9:00 to 13:00 and must be parked there until the end of the event.



#### "SERVICE" Plate:

- Vehicles less than 3,500 kg (van) used asservice assistance.
- These vehicles can enter in the servicepark every day of the event.



## "TEAM MANAGER" Plate:

- Vehicles less than 3,500 kg for the transfer of the team staff.
- These vehicles can enter in the servicepark every day of the event.

## Art. 11.9.2 Identification of team personnel

In service areas, after the start of the competition, only 3 team personnel may work on competing vehicles driven by FIA Platinum/Gold priority drivers. They will be identified by Arm band provided by the organiser.

## Art. 11.9.3 Service allowed in Selective Section

In accordance with article 49 of the FIA CCR SR, any service is forbidden during Selective Sections. Only crews with FIA groups vehicles still in the competition for the current Stage/SS may assist each other.

Service, pushing or towing done by the marshal / organization vehicles is authorized for safety reasons.

## Art. 11.9.5 Fuel and Refuelling Zone

Except as detailed for the change of a fuel tank, refuelling in the service area is not permitted at any time.

The crews may refuel only in the designated Refuelling Zone (RZ) or at commercial filling stations indicated in the Road book.

The Refuelling Zone (RZ) will be at:

Pordenone Fiere: "Parking SUD" (N 45°56.775' - E 12°39.142')

#### It is mandatory to reserve the area for refuelling.

In the RZ the procedures according to Art. 54.2 of the FIA CCRSR must be followed. To access the RZ, all personnel involved in refuelling operations must wear clothing that provides adequate protection against fire and includes at least: long trousers, long-sleeved top, closed shoes, gloves and a balaclava. Engines must be switched off throughout the refuelling operation and the crew must remain outside the vehicle during refuelling.

According to article 54.1.6 of the FIA CCRSR the team is responsible for the refuelling and must protect the ground with an environmental mat. This applies not only to the actual refuelling process but also to the handling and storage of the tank barrels.

Any infringement will be reported to the Steward.



# Appendix 4 – Extracts from FIA ISC Appendix L relating to overalls, helmets and any other safety requirements.

All competitors are reminded of Appendix L of the FIA International Sporting Code, in particular its Chapter III - Drivers' Equipment.

#### Helmets (Appendix L, Chapter III, Art. 1)

All crews must wear crash helmets homologated to one of the FIA standards listed in Appendix L.

## Frontal Head Restraint (FHR, Appendix L, Chapter III, Art. 3)

All crews must use FIA approved FHR systems homologated to FIA standard 8858. Approved FHRs, anchorages and tethers are listed in Technical List N° 29. See also helmet compatibility chart in Appendix L, Chapter III, Art. 3.3.

#### Flame-resistant clothing (Appendix L, Chapter III, Art. 2)

All drivers and navigators must wear overalls as well as gloves (optional for navigators), long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2000 standard (Technical List N°27) [Note: FIA 8856-2000 standard is valid for Regional Baja-Cups only. In the event of a Baja counting both for the World Cup and a Regional Cup, only clothing complying with FIA 8856-2018 standard may be accepted.] or to the FIA 8856-2018 (Technical List N° 74). Please pay special attention to the prescriptions of Art. 2 concerning the correct wearing of the clothing elements! See also FIA Cross-Country Rally Sporting Regulations Article 47.1.

Any FIA-approved 8856-2018 garment customised using printing or transfers must be accompanied by a certificate from the manufacturer.

#### Biometric Devices (Appendix L, Chapter III, Art. 2.1)

Drivers may wear a device to collect biometric data during racing.

- If the biometric device is integrated into a protective garment homologated to FIA Standard 8856, the garment shall be homologated to FIA Standards 8856 and 8868-2018.
- If the biometric device is a stand-alone device, then the device must be homologated to FIA Standard 8868-2018 only. This device must be worn in addition to the garment homologated to FIA Standard 8856.

## Wearing of jewellery (Appendix L, Chapter III, Art. 5)

The wearing of any type of jewellery, such as but not limited to, neck chains, bracelets or watches is prohibited during the competition. Exceptions to this rule, providing the CMO and/or Medical Delegate do not consider that due to size or location they may delay rescue or hinder emergency care, are:

- i. the wearing of watch(es) by navigators, on the condition that the watch(es) is worn over the overall,
- ii. the wearing of a single band-style ring providing it does not restrict the natural range of motion of the hand, and
- iii. the wearing of body piercing(s) providing they are not worn in and/or around the oral cavity.
