**The stewards have received a report (CoC Report No. 5/ doc. 3.19) from the Clerk of the Course, having received and seen the video material, have considered a matter, determine the following:**

Die Stewards haben einen Bericht (Bericht Rallyeleiter Nr. 05 / Dok.Nr. 3.19) des Rennleiters erhalten, entsprechendes Videomaterial erhalten und gesichtet, einen Vorgang betrachtet und folgendes entschieden:

**Fact:** Car no. 15, on 15/10/2022, approaching the special stages 11 (at 14:10hrs), 12 (at 14:42 hrs) and 13 (at 16:54hrs) was reported for negligent driving when zigzagging aggressively, invading lane in the opposite direction, without risk for road users.

**Offence:** Breach of Art. 12.2.1.c and Art. 12.2.1.f of the 2022 FIA International Sporting Code  
Breach of Art. 1.1 Supplementary Regulations

**Decision: Fine of 300€ to be paid by the driver**

In accordance with Art. 12.8 FIA Sporting Code, the payment of the fines must be done online, within 48 hours after their notification, at <https://fiafines.fia.com>. Any delay in making the payment may entail suspension during the period a fine remains unpaid.

**Reason:** The video material shows clearly that the car was driving zigzagging aggressively on open roads.  
After watching the video evidence, the stewards concluded, that the driver, in proceeding as described above, did not take the necessary care on public road.  
The FIA is dedicated to improving the safety of everyday road users throughout the world. As a global campaigner, the FIA plays a leading role in promoting awareness and responsibility not only among motorists, but all road users through education, campaign and information. The behaviour of the driver is in contradiction of one of the major objectives of FIA and thus a breach of ISC Art. 12.2.1.c. According to Art. 12.2.1.f any deeds that have caused moral injury to the FIA may be penalised by the stewards.  
According to the code, fia licence holders and all participants in international competitions must not pursue any objective that diverges from those of the FIA. The conduct of the driver is prejudicial to the interest of the 3 Städte Rallye and to the interests of motorsports generally.

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with article 15 of the FIA International Sporting Code and article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
