The Stewards, having received a report from the Chief Scrutineer, have considered the following matter and determine the following:

Facts During routine checks at the Stop Control of SS 3, car No. 33 was found with the control unit of the extinguishing system not in operating position.

Offence Breach of Article 253-7.2 of Appendix J to the 2022 FIA International Sporting Code

Decision Fine of € 100 on Competitor No. 33

In accordance with Art. 12.8 of the 2022 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail suspension of the licence during the period a fine remains unpaid.

Reason The Competitor was informed accordingly by the Stewards and was given the possibility, if he wished, to bring forward any representations other than having forgotten to activate the extinguishing system.

The Competitor informed that he would not make any further representations.

As stipulated in Art. 253-7.2.4 of Appendix J to the 2022 FIA International Sporting Code, the system must be armed at all times. Art. 253-7.2 of Appendix J to the 2022 FIA International Sporting Code does not specify when the system can be switched on or switched off. For this reason, it must always be active during the rally.

The fire extinguishing system is a major safety item to protect the crew in case of fire in the car and it is essential for the crews' safety. Safety remains a key challenge and the FIA is committed to do everything possible to protect, among others, the crew.

The Stewards therefore conclude that this is a breach of Art. 253-7.2 of Appendix J to the 2022 FIA International Sporting Code.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2022 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
