Competitor/Driver: n.23 Prema Racing-Lindblad Arvid Anand Olof

Time (fact): Lap 12

Session: Race 2

Fact: Caused a collision with another car

Offence: Art.4.3 q) e art.2 All.A1 Linee Guida RDS Velocità in Circuito 2023

Decision: To drop the car 4 grid positions at next race in which the drivers will take part

Reason: After reviewing the matter, the Stewards determined that Driver #23 caused a collision with car #15 at T1-2 having responsibilities. Therefore, the Stewards found that the said driver violated the regulations and therefore impose this penalty.

The decision is based on the art. 210.3 III, 215, 215 bis, 216 bis, 227, 228 229 of the RSN within its area of responsibility or competence.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with the ACI National Sporting Code and the ACI Judicial Rules, within the applicable time limits.
