The Stewards, having received the report from the Chief of Scrutineering regarding Competitor K3 Motorsports car #12 have and hearing the Competitor representative, considered the following matter and determine the following:

Facts Car was found underweight after Heat 2

Session Heat 2 Race 1 Yaris1000

Offence Breach of YARIS 1000 Rallycross Technical Regulations 2026 art. 5.1.

Decision Disqualification imposed on the Driver Amands KRIVENKOV from the Heat 2.

Reason Car No. 12 was weighed by the technical inspection after the end of Heat 2 Race 1, and the weighing result was 893 kg. The driver was present during the weighing and confirmed the result. The Stewards determined that the relevant technical regulation article 5.1 was breached and decided that the appropriate penalty is to disqualify the driver from the race session. Stewards acknowledged that even though the underweight is 7 kg the disqualification is only appropriate penalty.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2026 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.

Rikkumine	YARIS 1000 Rallikrossi Tehnilised Tingimused 2026 punkt 5.1 rikkumine.
Otsus	Diskvalifitseerimine sõitjale Amands KRIVENKOV sõiduvoorust.
Põhjustus	Auto nr. 12 kaaluti tehnilise kontrolli poolt peale Heat 2 Race 1 lõppu ja kaalumise tulemuseks oli 893 kg. Sõitja viibis kaalumise juures ja kinnitas kaalumise tulemust. Žürii tuvastas, et on rikutud tehniliste tingimuste punkti 5.1 ja otsustas, et õiglaseks karistuseks on sõitja võistlusvoorust diskvalifitseerida.

Võistlejatele tuletatakse meelde, et neil on õigus teatud žürii otsuseid edasi kaevata vastavalt FIA rahvusvahelise spordikoodeksi artiklile 15 ning FIA kohtulike ja distsiplinaarreeglite 4. peatükile.
