The Stewards, having received a report from the Clerk of the Course summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

Facts The Crew of Car No. 70 entered parc fermé approximately 15 minutes ahead of their

due time at TC1B.

Offence Breach of Article 63.2.2 of the 2025 FIA WRC Sporting Regulations.

Decision Fine of € 1000 jointly and severally on the Crew of Car No. 70 (JORGE MARTÍNEZ /

JOSÉ ALBERTO AROS).

In accordance with Art. 12.8 of the 2025 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail

Suspension during the period a fine remains unpaid.

Reason The Stewards, having received a report from the Clerk of the Course, summoned and

heard from the Driver Mr. JORGE MARTÍNEZ, Co-driver Mr. JOSÉ ALBERTO AROS and from the Competitor's Representative, Ms. ISABEL ORTIZ of Car No. 70.

The crew was reported to have entered parc fermé approximately 15 minutes ahead of their designated time at TC1B. Upon enquiry, the Driver acknowledged the mistake and expressed his apologies for their lapse in judgement. He stated that he had relied on the instructions of his Co-driver, who had limited experience in FIA WRC events. While affirming their understanding of parc fermé regulations, they admitted to entering parc fermé ahead of their scheduled time by error.

Article 63.2.2 of the 2025 FIA WRC Sporting Regulations states that "Crews may enter the parc fermé 10 minutes before their starting time". The Stewards stressed and reaffirmed the importance of adherence of this regulation and other requirements of parc fermé.

Given that the crew is classified as non-priority, the Stewards consider a €1,000 fine to be a proportional and appropriate penalty for this breach.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2025 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
