- having considered that cars No. 32, 37, 42, 38, 40, 43, 46, 41, 45, 47, 54, 56, 49, 50, 64, 63, 51, 67, 66, 77, 65, 71, 60, 70, 58, 59, 61, 73, 62 & 76 were stopped at the start of SS 16 and instructed to drive through the stage non competitively
