Discover the new *Licence for team members*

Dear Madam,
Dear Sir,

We are pleased to announce the forthcoming launch of the ***Licence for team members***, an initiative specifically designed to protect and support team members in their daily professional lives. The FIM has decided to create this *Licence for team members* with full insurance cover in order to offer an optimal coverage for professional activities related to the following **FIM events**: FIM World Championships and Prizes with or without promoter and FIM Training Camps.

Why is this licence essential? It enables team members to benefit from extensive **individual insurance coverage**, valid at the **FIM events described above**:

- **in the paddock, on the starting grid, in the pit lane and service road;**
- **during business trips (home - FIM event venue - home);**
- **for all professional activities related to the said FIM events** (on the geographical location and time frame of the said FIM event), **including motorbike testing on the circuit.**

What does this licence include?

Per year:

- **Basic package** (€120 per year) : emergency medical assistance and repatriation, insured by our insurer Mutuaide.
- **Additional option** (€58 extra per year): coverage in the event of death or disability, provided by our insurer Mutuaide.

Per event:

- **Basic offer** (€91 per event): emergency medical assistance and repatriation, insured by our insurer Mutuaide.
- **Complementary option** (additional €50 per event): coverage in the event of death or disability, insured by our insurer Mutuaide.

How to subscribe?

Each person will be able to subscribe directly to the FIM, simply and securely via the FIM Extranet (<https://extranet.fim.ch>), with an individual account as of **1 January 2026**.

This new licence will remain optional throughout 2026.
