### 4.2 INVITATIONAL CATEGORY

4.2.1 ~~Invitational category allows the inclusion of historically homologated cars featuring forced induction and/or four wheel drive up to and including period J2 cars (those manufactured between 1st January 1986 — 31st December 1990)~~

The category will be open to cars featuring forced induction and/or four-wheel drive homologated on or before 31st December 2000.

4.2.2 The selection and approval of potential entrants will be at the Organiser's discretion

4.2.3 Results and awards for the Invitational Category will be separate from the main category. Awards will be presented to the winning Driver and Co-Driver for the Invitational Category. Results for the Invitational Category will be published separately to the Main Rally Results at the end of each Leg and at the Finish of the Rally.

4.2.5 Competitor Eligibility for the Invitational Category is as per Supplementary Regulations Article 5.1.



- 4.2.6 Entry Fees for the Invitational Category are as per Supplementary Regulations Article 5.4.
- 4.2.7 Entry Packages for the Invitational Category are as per Supplementary Regulations Article 5.5.
- 4.2.8 The Itinerary for the Invitational Category will be identical to the Main Rally Itinerary.
- 4.2.9 Invitational Category Cars will be included on the Overall Start List at the beginning of each Leg, and will be seeded in order of anticipated performance.
- 4.2.10 Invitational Category Cars will start each leg at the front of the field, ahead of the Main Rally field. A suitable time gap between the last Invitational Category Car and 1st Main Rally Category Car will be managed via Rally Control.
- 4.2.11 All other Supplementary Regulations Articles not specifically mentioned in this Bulletin will apply to the Invitational Category Competitors and Service Crews and associated vehicles.

## 5.1 COMPETITOR ELIGIBILITY

- 5.1.1 ~~Any person~~ Drivers holding an International Competition Licence and a Valid Driving license are eligible to enter. Co-Drivers holding a National Competition Licence are eligible to enter. All foreign competitors must have a letter of authorization from their respective ASN's.
