All Competitors / crew members

The Stewards, having become aware of an incident, summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

Facts The crew of car No. 27 ROBERTO DAPRÀ / LUCA GUGLIELMETTI was driving "zigzag" using the whole width of the road on the road section to Special Stage 5 on Friday, 6th June 2025.

Offence Breach of Article 34.3.1 of the 2025 FIA WRC Sporting Regulations

Decision Fine of € 200 on Competitor/Driver No. 27 (ROBERTO DAPRÀ) as per Article 34.3.4 a) of the 2025 FIA WRC Sporting Regulations (1st traffic infringement other than speeding during the competition element of the rally).

In accordance with Art. 12.8 of the 2025 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason The Stewards reviewed video evidence on the incident. The video showed the Crew weaving across the road using the whole width of the road while the road was obviously open to public traffic.

The Stewards heard the driver ROBERTO DAPRÀ and co-driver LUCA GUGLIELMETTI of car No. 27 on 7th June 2025 at 20:20 hrs in the presence of the Team Representative SIMONE SCATTOLIN.

The Crew stated admittingly that they recognised the offence that had occurred and in hindsight that such driving behaviour was incorrect. They apologised for their lapse in judgement.

The Stewards decide to levy a fine for this 1st traffic infringement. Driving erratically in the manner seen in the video does endanger or inconvenience other traffic or people living near these traffic routes.

Competitors and Crews are reminded of the importance of abiding by traffic regulations while driving on roads as stipulated in the 2025 FIA WRC Sporting Regulations. Moreover, it is to be noted that the COC had also reminded all competitors in COC Communication No. 1 on the rules related to the driving behaviour.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2025 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
