The Stewards, having received a report from the Clerk of the Course with documentary evidence attached, summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

Facts Failure by the crew addressed above to activate the OK display on the FIA Safety tracking device within one minute after stopping on SS10 (Pavliani 2) on Saturday, September 9th, at 16:26 hrs.

Offence Breach of Art. 53.3.3 of the 2023 FIA WRC Sporting Regulations.

Decision Having considered that Mr. SLAVEN ŠEKULJICA is a non-priority driver, Driver SLAVEN ŠEKULJICA and Co-driver DAMIR PETROVIĆ shall be jointly and severally liable to pay a **fine of € 250**.

In accordance with Art. 12.8 of the 2023 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason The crew was informed accordingly by the Stewards and was given the possibility, if they wished, to bring forward any representations other than having forgotten to activate the OK display within one minute in the heat of the moment.


The driver Mr. SLAVEN ŠEKULJICA and co-driver Mr. DAMIR PETROVIĆ as well as the team representative Mr. Giorgio MARAZZATO appeared in front of the Stewards on September 9th 2023 at 22:35 hrs to make their representations.

The driver stated that when he stopped on the stage, he immediately pressed the "OK" button, and they then started moving before they had to stop again. The Stewards explained the data extracted from the tracking system data of Car 83.

The data from the FIA Safety tracking system showed that Car 83 stopped on the stage at 16:15:25 for the first time and acknowledged "OK" within one (1) second. At 16:26:16, the car stopped a second time, for a duration of 00:02.43 without confirming "OK" before starting to move again.

The Stewards conclude that a breach of the above regulations occurred and that the penalty imposed is in line with previous precedents.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2023 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
