The Stewards, having received a report from the Clerk of the Course with documentary evidence attached, summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

Facts Failure by the crew addressed above to activate the OK display on the FIA Safety

tracking device within one minute after stopping on SS6 (Elatia) on Friday, September

8th, 2023, at 18.07 hrs.

Offence Breach of Art. 53.3.3 of the 2023 FIA WRC Sporting Regulations.

Decision Having considered that Mr. GAURAV GILL is a FIA priority 2 driver, Driver GAURAV

GILL and Co-driver FLORIAN BARRAL shall be jointly and severally liable to pay a

fine of € 1000.

In accordance with Art. 12.8 of the 2023 FIA International Sporting Code, fines shall be paid within 48 hours of their patitions. Any delay in making payment may entail

be paid within 48 hours of their notification. Any delay in making payment may entail

Suspension during the period a fine remains unpaid.

Reason The crew was informed accordingly by the Stewards and was given the possibility, if

they wished, to bring forward any representations other than having forgotten to

activate the OK display within one minute in the heat of the moment.

The crew confirmed that they did not want to make any further representations.

Art. 53.3.3 of the 2023 FIA WRC Sporting Regulations explains the procedures that the Crew must undertake in case of stoppage of their car on a special stage whether temporarily or permanently. The Crew must acknowledge the status of the stoppage within one minute of being prompted to do so on the FIA Tracking System. A fine is

therefore applied for this infringement.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2023 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
