The Stewards, having received a report from the FIA Deputy Technical Delegate, summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

- **Facts** The mandatory markings (stickers) linked to the FIA technical passport of Car 71 were not present at pre-event scrutineering.
- Offence Breach of 2023 FIA ISC, Appendix J Article 251-2.1.8.

Decision Fine of € 500 on Competitor No. 71

In accordance with Art. 12.8 of the 2023 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason The Stewards having summoned the above Competitor and team representative, heard from the Driver FILIP PYCK and Co-Driver PETER DEHOUCK. The team representative was occupied and in the service park and was not able to attend. The Crew agreed to have the hearing without their team representative.

The Co-Driver explained that the car was purchased recently, in 2023, and that the team, upon receiving the car, realised that they had to undertake major work to dismantle and repair it to deem it ready to compete. During this repair process, the mechanics noted that the FIA Passport's mandatory markings (stickers) were missing. The Competitor, proactively, contacted the FIA Technical Delegate to report the missing FIA Passport markings (stickers) ahead of Acropolis Rally Greece 2023. The FIA Technical Delegate, subsequently, confirmed back that they should report the matter to the Stewards before rectification.

Having considered the matter extensively, the Stewards determined that, nevertheless, an infringement of the above article had occurred and that the stipulated fine is appropriate and in line with past precedents. A replacement FIA marking (sticker) shall be applied by the FIA Technical Delegate in due course.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2023 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
