

- Media will be allowed to conduct interviews with the crews in the pre-podium holding after TC 20A.
- ~~At the finish at the Media Zone, after the car is driven into the final parc fermé.~~






C) Judge of fact

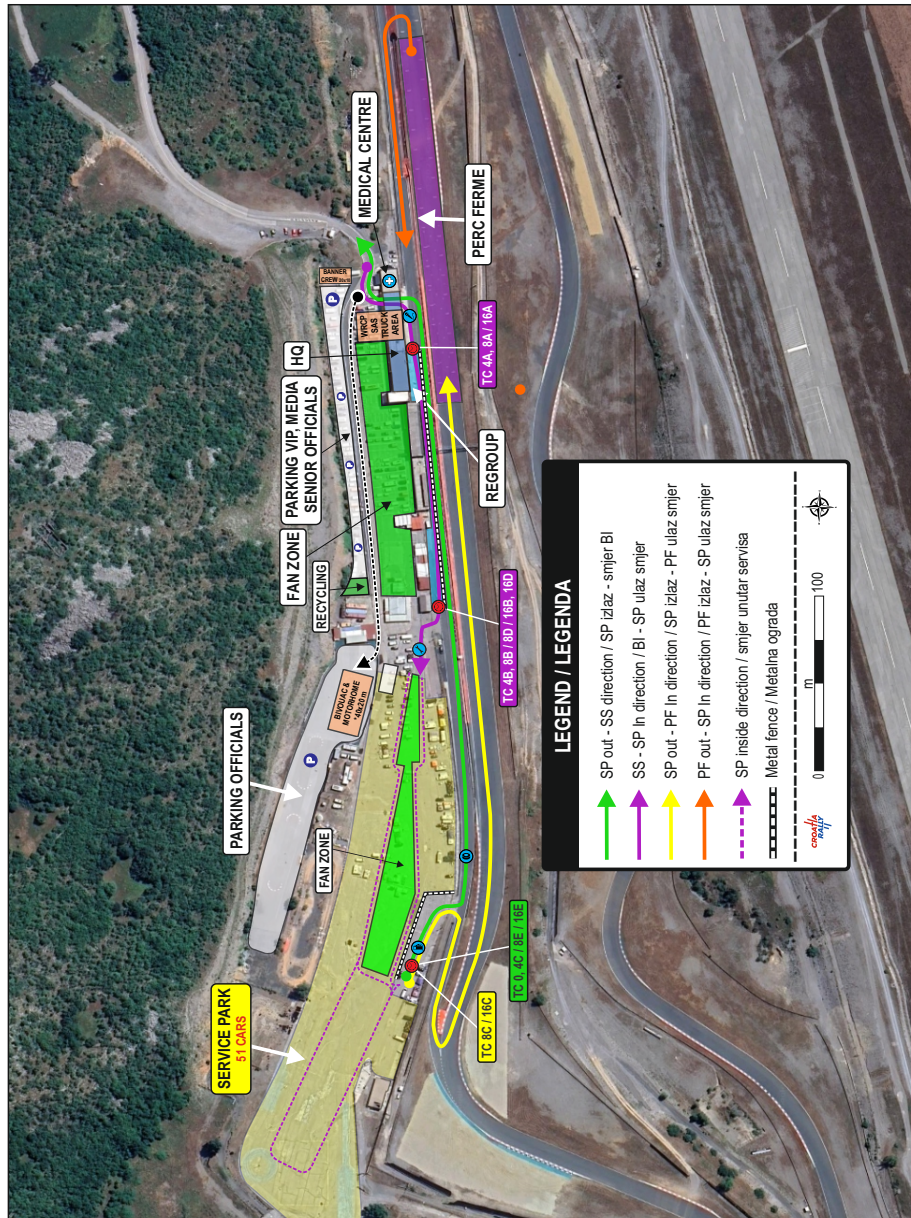

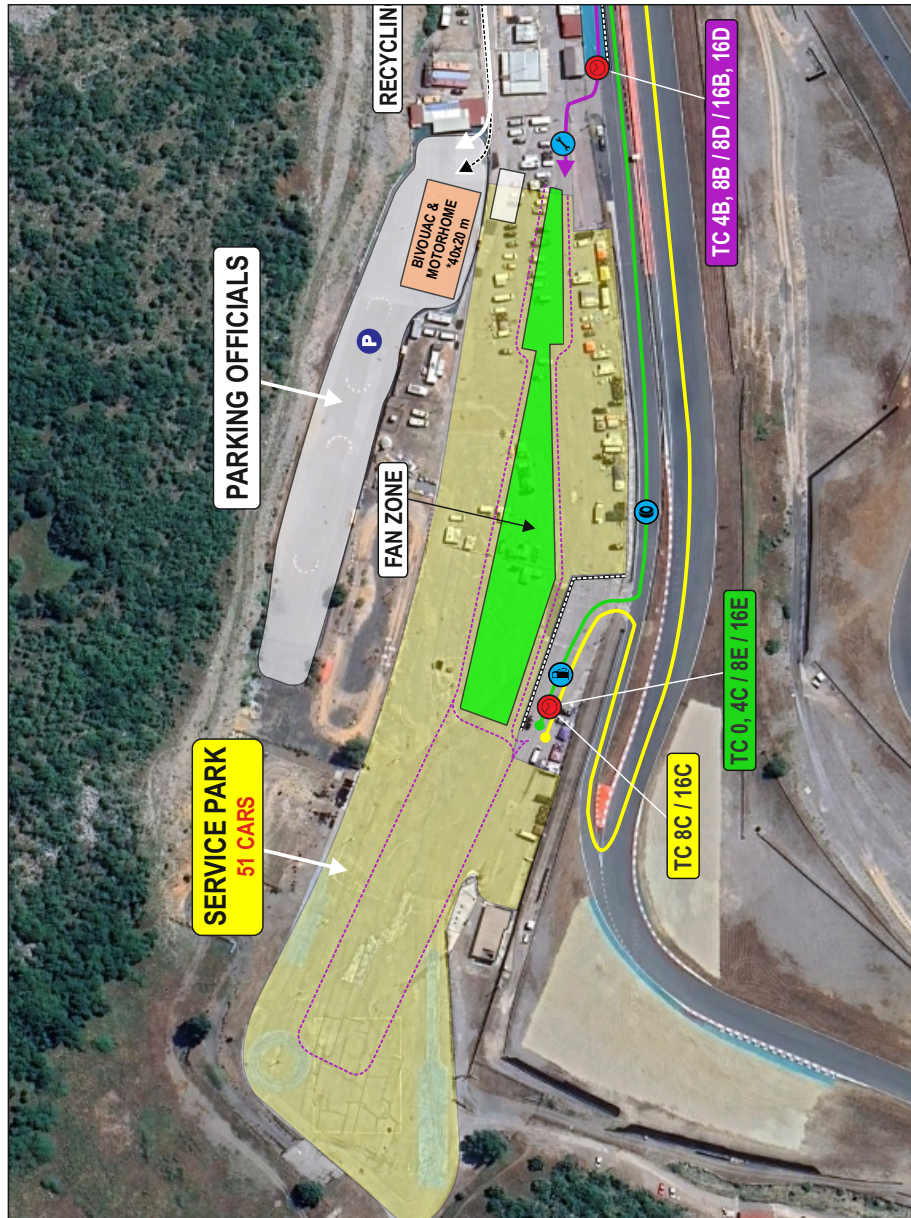

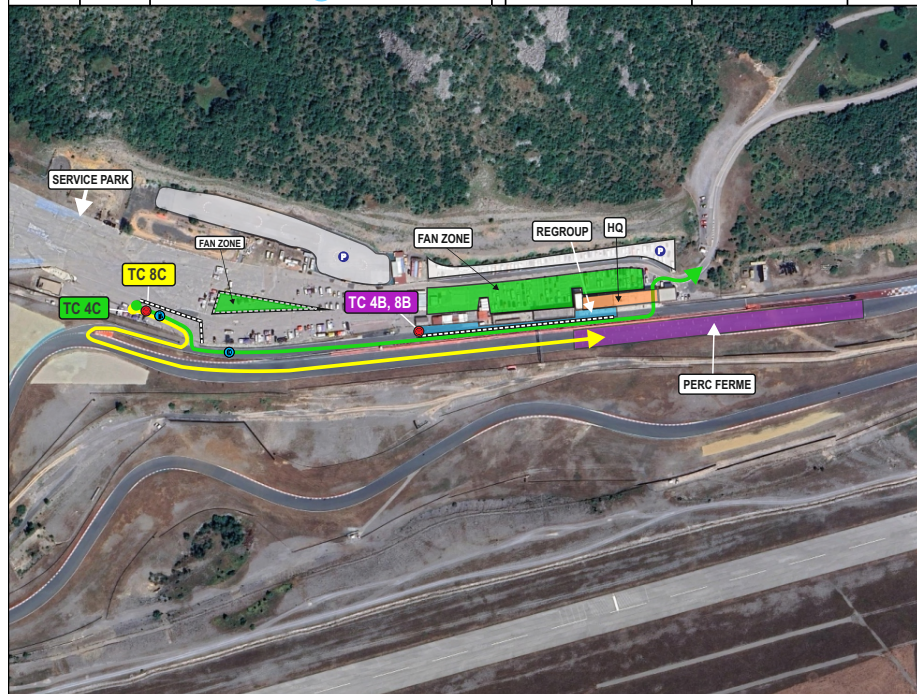
AUTOMOTODROM GROBNIK LAYOUT



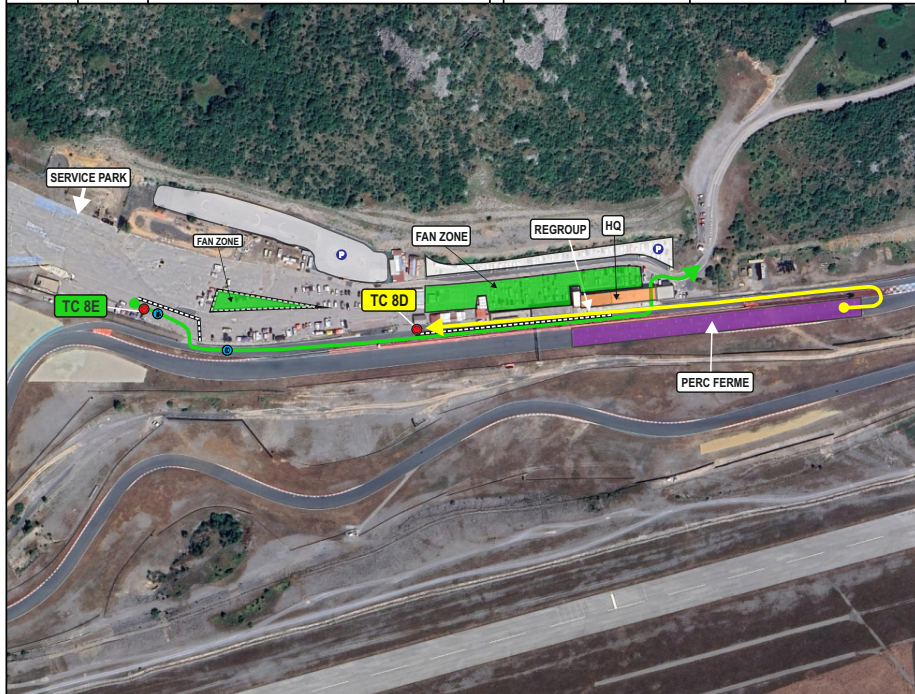

RALLY PARK LAYOUT



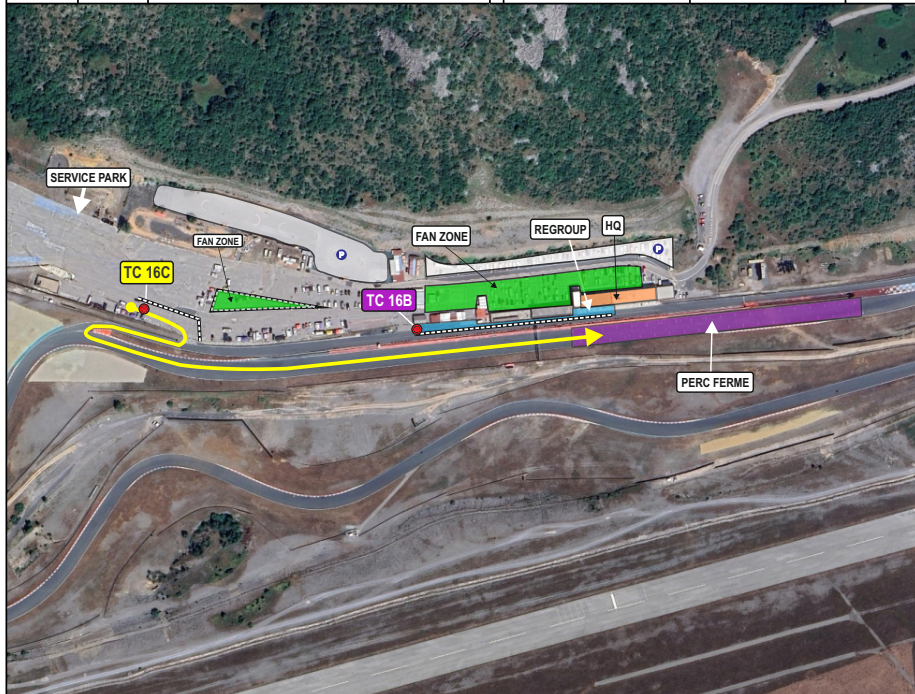
