The Stewards, having received a report from the ASN Technical Delegate, summoned the above crew members, have considered the following matter and determine the following:

**Facts:** During routine checks at the end of SS 7 the driver of Car no. 4 was found to be using a helmet which was not the one approved at scrutineering prior to the event.

**Offence:** Breach of Art. 31.1.2 of the FIA 2025 RRSRs and Art. 11.4 of the event SRs.

**Decision:** - **To impose a fine of €1,000 on Competitor of Car No. 4, suspended** until 31<sup>st</sup> December 2025, subject to no further breaches of the regulations regarding the use of personal safety equipment are committed by the competitor during this period.  
- **To impose a reprimand on Competitor of Car No 4.**

**Reason:** The Stewards heard from the driver of Car No. 4 who apologised for the error that had occurred with respect to the use of a different helmet. He explained that due to a number of problems in the lead up to the event he had left the matter of presenting the correct safety equipment at scrutineering to his mechanics. For reasons that he could not explain the mechanics presented an incorrect helmet at scrutineering and not his personal helmet.

Once the error had been discovered by the scrutineers the driver stated that he had immediately checked to ensure that the helmet he was using complied with the appropriate standards and this was confirmed by the scrutineers.

The Stewards acknowledge that the helmet used by the driver was compliant with the required standards but note that there was a failure to comply with the requirement to present all items of safety equipment intended to be used on the event at scrutineering.

The use of an approved helmet is a vital safety requirement and the process of checking this equipment before the event is an important safety control.

The Stewards consider the use of a helmet which has not been checked for compliance, even though it meets the required standards, is a breach of the regulations and decide that it is appropriate to impose a penalty of a reprimand and, in this instance, a suspended fine. This is intended to ensure that this competitor will take care to ensure that at all future events the personal safety equipment presented at scrutineering is to the correct standard and is the actual equipment that they will use.

The decision is based on the FIA International Sporting Code Art. 11.9.1, Art. 11.9.3.a and Art. 11.9.3 f.

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
