## **YOUR OBLIGATIONS**

Where a penalty applied includes a fine, the National Sporting Code (Part VIII – Penalties, Article 97) requires you to pay all fines and costs imposed to MotorSport New Zealand within 48 hours of the Decision in which the fine was imposed.

Endorsements and/or Suspensions are processed within the MotorSport New Zealand database which will provide automated emails to the competitor.

## **YOUR RIGHTS**

You have the Right of Appeal, in accordance with the provision of the National Sporting Code, to the National Court of Appeal.

If you decide that you wish to exercise this right, then:

- Consult the National Sporting Code Part XI Appeals.
- Obtain from the Stewards, Clerk of the Course or Competitor Relations Officer a copy of the Court of Appeal Practice Guidelines.
- Complete and deliver a "Notice of Intention to Appeal" form to the Stewards in accordance with National Sporting Code Part XI – Appeals.
- 4. The "Notice of Appeal" against any penalty or decision (accompanied by such fee as may be stipulated by MotorSport NZ from time to time) must be received by the Secretary of the National Court of Appeal at MotorSport New Zealand within three working days of from the date of the decision of the Stewards.
- 5. The lodging of an appeal does not of itself suspend the application or effect of any penalty imposed which is the subject of, or a consequence of, the appeal lodged.
