Entry procedure

- **All details entered MUST be true & accurate for Motorsport UK, Reis Road Risk Insurance and MCMC Seeding purposes.**
- Entries must be paid in full, including insurance for the event, Membership is necessary unless a current ANICC member.
- An entry will only be accepted when accompanied by the total entry fee.
- TBA can be used but note only one amendment per entry can be made
- Payment of entries is via **BACS** details:- **will be advised on Rallyscore.**

Entry Selection Criteria

Places will be allocated to **Drivers** in the following order:

1. The first three in each class in the McGrady Insurance Motorsport UK ANICC Northern Ireland Stage Rally Championship at the final closing date for entries.
2. MCMC reserve the right to select 20 competitors at their discretion.
3. Any current MCMC member prior to publication of these regulations

ALL of the above is based on receipt of fully completed entry forms and payment

If more than 100 entries are received a reserve list of up to 20 potential competitors may be assembled. All the correspondence will be posted on www.maidencitymotorclub.co.uk On submission of your entry you will receive an email of acknowledgement, reserving entry. You will NOT receive any written correspondence in relation to the event from the club.

It is your responsibility to check webpage/Sportity regularly.

Additional Information re: Accepted Entries

- The number of competitors shall be limited to 100 plus 20 reserves and the minimum will be 80. Should the minimum figure not be reached, the Organisers reserve the right to cancel the meeting, amalgamate classes or reduce the rewards list as deemed appropriate.
- Competitors are advised that when completing the form online please do this as fully as possible, only ONE amendment to the form is allowed I.E. driver/navigator details, car or class until seeding of entries.

NB. When seeding is completed, the named driver CANNOT be changed.

- The starting order will be at the organisers' discretion, but to assist seeding, entrants must note their previous results on the Entry Form. Failure to disclose previous results may lead to incorrect seeding, which may not be rectified.
- Any indemnity and/or declaration as prescribed below which is signed by a person who has not reached their 18th birthday shall be countersigned by that person's parent or guardian, whose full name and address shall be given. Any entry may be made by electronic means of communication must be made by the parent or guardian, whose full name and address must be given (Motorsport UK GR H32 and D12.3.8).
- Any person under the age of 18 signing on as specified in Motorsport UK GR D13.1 (where the parent is not present) must be accompanied by a Guardian who must produce a written and signed authorisation from the Parent to act as Guardian (Motorsport UK GR D13.1.1).
- Organisers reserve the right to accept or refuse entries at their discretion. All entries will be acknowledged but will not be accepted until FULL payment is made.

Entry fee refunds

(follows guidelines issued by ANICC Stage Rallies Committee)

Stripe refunds take about up to 7-10 working days to reappear in the payees account

- Entry fees will be refunded, less an administrative charge of £10.00 up to 5th April 2024. From 6th April to 19th April entries will be refunded less an £50 administration fee. After this date refund of entry fees will be at the organiser's discretion, except in the circumstances referred to in Art 4.6.2. Reserve entries that are not offered a start will receive a full refund subject to Motorsport UK GR H30.1.3(c).

Refunds for entries withdrawn must be in writing or by E-mail. Entries withdrawn after this date will not receive a refund. Please note that withdrawn entries may still appear on entry lists.

No written notification to Secretary of Event, no refund.

VEHICLE CATEGORIES AND CLASSES

The championship will be divided into eleven Classes as per the ANICC McGrady NI Rally Championship Regulations 2024 as follows, please read the class notes overleaf prior to class entry

3	Clubman 2WD up to 1450cc Cars up to and including 1450cc—Two-wheel drive cars only. Cars from 1451cc up to and including 1650cc; having not more than 2 valves per cylinder Two-wheel drive Cars Only
4	Clubman 2WD up to 1650cc Cars from 1451cc up to and including 1650cc, having more than 2 valves per cylinder. – 2WD only.
5	Clubman 2WD up to 2100cc(2 valve) Cars from 1651cc up to and including 2100cc, having not more than 2 valves per cylinder.—Two-wheel drive cars only.
6	Clubman 2WD up to 2100cc(multivalve) Cars from 1651cc up to and including 2100cc, having more than 2 valves per cylinder –Two-wheel drive cars only.
7	Clubman 2WD over 2100cc Cars over 2100cc—Two-Wheel drive only.
8	Clubman 4WD Any 4WD cars not classified in class 9 or 10, without a sequential gearbox (including previously FIA Homologated GpN 4WD cars). 4WD Historic rally cars homologated before 31/12/90 (Motorsport UK Cat 1, 2, 3, 4a and 4b. Ref: R49-2024 Motorsport UK Blue book.) and 4WD Historic rally cars complying with FIA Appendix K. Ref: R49.2 of 2024 Motorsport UK Blue book.) (see Article 7.14)
9	National 4WD FIA Rally 3 FIA Homologated GpA 4WD cars and any cars previously homologated as such, providing these run as per their FIA homologation papers. FIA Homologated Super 2000 cars and any cars previously homologated as such, providing these run as per their FIA homologation papers. FIA Homologated R4 cars and any cars previously homologated as such, providing these run as per their FIA homologation papers.

10	International 4WD	<p>FIA Homologated Rally 2(R5), providing these are run as per their FIA homologation papers and FIA Homologated WRC cars and cars previously homologated as such, providing they are run as per their FIA Homologation papers.</p> <p>Including any derivative of FIA Rally 2 (R5) car converted to RHD whose conversion has been supported with photographic evidence and original LHD homologation papers for that vehicle. Championship organisers reserve the right to reclassify a car to class 11 if pre-event scrutineering reveals changes to the vehicle specification that are considered to improve the vehicle's performance.</p>

Class Notes from NI Rallies Committee Championship regulations:

- 5.1 The Championship will be divided into Vehicle Categories as follows: -
- 5.2 (a) Overall (b) FIA 2WD (c) Two Wheel Drive overall (d) Historic
- 5.3 The championship will be divided into eleven Classes (listed in Appendix 1).
- 5.4 The Overall Category is open to competitors in classes 1 to 10 only.
- 5.5 The FIA 2WD category is open to competitors in Class 2. See article 5.13 for eligibility.
- 5.6 The Two Wheel Drive category is open to classes 1, 2, 3, 4, 5, 6, 7.
- 5.7 The Historic category is open to competitors in Class 1 and eligible cars in Class 8.
- 5.8 All cars must comply with the current Motorsport UK vehicle regulations (including the requirement for all vehicles to produce a logbook or vehicle passport) appropriate to the individual event entered.
- 5.9 Competitors are reminded of requirements under 2024 Motorsport UK Yearbook - Competitors: Vehicles; Regulation J5.13.7 where all cars must be equipped with the facility to enable a fuel sample to be taken. Except as provided for in J5.13.7 cars issued with a current CCLB prior to 1 January 2009 are not required to have a self-seal connector.
- 5.10 All cars must have Mud Flaps fitted behind each wheel. See 2024 Motorsport UK Yearbook R48.1.12
- 5.11 See 2024 Motorsport UK Yearbook R 18.6.5/R 19.8.1/R 46.1.5: All competitors must carry within their vehicle a self-contained Spill Kit complying with J 5.20.13 capable of effectively absorbing minor spillages of up to 1.25 litres of all vehicle fluids – oils, fuels, coolants, battery acid. Used Spill Kits are to be disposed of in accordance with local or National guidelines.
- 5.12 Turbo engined cars, class determined by capacity x1.7; Rotary engined cars, class determined by capacity x1.7.
- 5.13 Vehicle Regulations for homologated and previously homologated cars in classes 1, 2, 8, 9, 10 and 11: The relevant FIA Homologation Papers must be produced at each event and cars must comply fully with FIA technical eligibility regulations (FIA Appendix J). Previously

homologated cars are defined as cars whose homologation has expired and they are permitted to compete in a previously homologated specification.

5.13.1 Group N Cars eligible for Class 2 and Class 8 are those, which are, or have at any time been, homologated in Group N as defined in FIA Appendix J.

5.13.2 The standard specification of any model shall be determined by FIA Homologation papers in the case of current and former Group N cars and all other FIA homologated or previously homologated cars.

5.13.3 In all cases the degree of modification from standard shall be as provided for under FIA technical eligibility regulations (Appendix J).

5.13.4 The onus of proving eligibility for any homologated car rests solely with the competitor who should ensure that homologation papers are available at events.

5.13.5 Regulation 5.12 applies.

5.14 Vehicle Regulations for Classes 1 and 8 (Appendix K) (Note: ALL competitors take note of Article 5.16). In order to run under Appendix K, Historic Rally Cars must have been issued with a valid FIA Historic Technical Passport (HTP), be in compliance with this document and the current FIA Appendix K at all times. Vehicles are exempt from R 46.1.3.

5.15 The onus is on every competitor to ensure that they are entered each championship event in the correct class.

5.16 The ANICC Rallies Committee have appointed the following Motorsport UK Licensed Scrutineer to act as Eligibility Scrutineer for the 2024 McGrady Insurance Motorsport UK Northern Ireland Rally Championship: Siobhann Deery.

5.17 Competitors by registering for this championship accept that their competing vehicle(s) may be checked throughout the course of this championship for compliance with the regulations for the class in which it is entered.

6. INSURANCES LICENCES

Day of Rally: Saturday 27th April.

Insurance

Vehicles must have a valid motor insurance policy which provides as a minimum, Third Party Liability cover that complies with the Road Traffic Act. This can be either, by extending an existing motor policy to cover the event, or, by purchasing additional cover, providing under the Event Road Section Scheme as an adjunct to an existing motor policy. If a competitor has an extension to their existing policy, they will be required to sign a declaration that the cover complies with the requirements of the Road Traffic Act. Any responsibility for a fraudulent or misleading declaration about existing cover lies with the competitor.

If a competitor wishes to purchase additional Road Section cover via the organisers then they can do so prior to the event providing they comply with the following:

- **is aged 19 years or over**
- **has held a full driving licence for a minimum of 6 months**
- **has no more than 6 points on their licence**
- **has had no more than 1 fault claim in the last 3 years**
- **is a named driver on a valid motor insurance policy for the vehicle they are driving**
- **do not have the Third-Party Extension cover on their existing motor policy**
- **the vehicle has a valid MOT and taxed for the road, unless exempt from doing so**

Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25. Any competitor who falls outside these parameters may be offered cover at equivalent terms or an agreed price, if approval from the Appointed Insurance Broker has been obtained by the event organisers, prior to the event.

Approval can be sought by sending an email to contact@reis.co.uk and provide the Drivers' name and date of birth, the date they past their driving test and details of any motoring claims and/or convictions.

Additional cover provided by this scheme is only effective whilst the vehicle is actively competing in the event and remains under the control or direction of the event organiser(s).

Cover will cease immediately if you are precluded, excluded or retire from the event.

The Event Road Section scheme is provided by Reis Motorsport Insurance and underwritten by First Underwriting Limited.

This cover will provide Competitors who need to use the scheme with Third Party Cover necessary to meet Road Traffic Act (RTA) Insurance Scheme on the Road sections of the Event. The basic rate is **£29.00**, per day. (before any Loadings i.e. if unable to comply) i.e. Event (This cover is included in the entry fee).

Road Risk Insurance will be offered via Maiden City Motor Club. The insurance provider for the event is Reis Insurance, application will be via www.rallyscore.net

6.1 Due to the remote administration of event entries please be aware that the competition car details as stated on the submitted entry form will be forwarded to REIS for cover during the event.

6.2 By signing the Rallyscore entry form the driver assumes responsibility and associated liabilities that the competition car details submitted on said form are accurate and correct with regard to the competing in the Eakin Bros BJT Rally 2024.

6.3 The Organisers have applied to REIS for a Blanket Cover Note under the above scheme. This will provide competitors who need to use the scheme with the Third Party Cover necessary to meet RTA requirements on the Road Sections of the event.

6.4 It is a requirement under this legislation that:

- Entrants and drivers must have valid insurance covering them against liability for both personal injury to and/or damage to property of Third Parties on public road sections of the event.
- It is the Entrants' and drivers' responsibility to arrange such insurance and/or to extend existing insurance, as necessary. Entrants and drivers will be required to sign and confirm that they are covered by such insurance.

- Failure to have such insurance may mean that the competition car in question may be refused permission to start the event.

6.5 The insurance cover will come into effect from the start and will cease at the end of the rally or at the moment of Retirement, Disqualification or Exclusion.

6.6 The basic rate for the event before any loadings will be: £29

6.7 All applicants wishing to use the scheme must be able to comply with all points of the REIS policy

- **is aged 19 years or over**
- **has held a full driving licence for a minimum of 6 months**
- **has no more than 6 points on their licence**
- **has had no more than 1 fault claim in the last 3 years**

6.8 Due to the implementation of a remote signing on procedure all competitors must complete a Driver Declaration Form (DDF). This form will be emailed to the driver once their event entry form and full entry fee, including the £29 Insurance premium, have been received by the Organisers. The DDF is to be returned to the Entries Secretary to complete the "acceptance" of the entry to the event.

6.9 AMENDMENTS TO DETAILS OF COMPETITION CARS, must be made in writing by emailing to the Secretary ruthc2270@gmail.com. The deadline for amendments is 23:59 on MONDAY, 8th April 2024. Please quote your Name and Rallyscore Entry number (RSE) in the title of your email.

6.10 The Organisers decline liability in any accident caused by or to competitors and the competing cars during the whole of the event. The Organisers also decline any liability for breach of the laws and regulations of Northern Ireland covered by the itinerary. Competitors shall be held responsible for any accident or breach of laws in which they may be involved and shall declare to the Organisers particulars of any incident from which liability may arise and shall have no claim against the Organisers arising out of any action of the Organisers, their servants, or officials, during the course of the Rally.

****All material facts must be disclosed. Material facts are those likely to influence the acceptance or assessment of your risk. Failure to disclose Material facts may lead to the Insurer Declaring the resultant cover to be null and void. If you are in any doubt about the facts that may be considered to be material these should be disclosed via a RTA Proposal application form is obtainable via emailing ruthc2270@gmail.com. Please apply ASAP to allow sufficient time for a letter of acceptance to be issued.**

This will be available at **Robinsons Concrete, Claudy BT47 4JA,**

The gates of the service area will open at 06:00hrs on Saturday 27th April.

Noise Test, Scrutineering of Vehicle & Driver/Navigator's safety equipment

Rally cars must be presented in same condition as they intend to compete. A valid MOT/NCT Test Certificate, Tax, must available for production at Scrutineering for any car required by UK law to have one.

A Noise Test, Inspection of Driver & Co-Driver's Rally wear, Helmets/FHRs of ALL cars will take place in the Service Area from 06:00hrs -10:00hrs.

The Scrutineering Team will assess ALL cars, while complying with the Covid guidelines applicable.

All cars must carry: OK/SOS board, Warning Triangle, Spill Kit & Sanitizer. All reports, e.g. Non- Compliance, Noise Schedule, etc will be transferred digitally to the Stewards and the Clerk of the Course.

Failure to attend scrutineering within the time specified = Disqualification.

Service Area

Reminders within the service area:

- Driver with respect and responsibility within the service area. i.e. 5-10mph
- Only one Service Plate will be issued per competitor. Strict limitation of vehicles entering Service Park will be in place. **NO PLATE NO ENTRY.**

- All crews MUST provide and use a ground sheet as the grounds are kindly on loan by the local business.
- Refuelling is ONLY permitted twice - at the 1st and 2nd Service at the designated refuel area.
- The service van must carry a Fire Extinguisher.
- Please use the bin provided for the oil and rags.
- Crews and Service Crews MUST obey the all Marshalls on the event at ALL times.

9. Reconnaissance Procedure:

Competitors may make ONE choice of day for a low speed (30 mph) reconnaissance at time of application via www.rallyscore.com during the following times:

Sat 20th April 2024: 10:00 - 15:00hrs (Dennet Interchange - Dunamanagh)

Fri 26th April 2024: 10:00- 15:00hrs (Dennet Interchange - Dunamanagh) Collection of Road Books/Paperwork will be 10:00 – 11:00 each day

Only **1 A5 size Road Book/per crew** will be issued, collectable on chosen date.

From publication of these regulations any competitor found on the stages outside of Recce date will be excluded, NO EXCEPTIONS!!

To enforce this regulation all the people named in these SR's (and additional Final Instructions) have been appointed judges of fact.

During the reconnaissance period the PSNI and the organisers will arrange speed checks and general patrols of the special stages, and competitors driving or being driven at an excess speed or in a manner which in the opinion of the organisers causes or could cause danger or inconvenience to other road users or local residents or could bring the sport into disrepute will be penalised as follows:-

1st offence – 2 MINUTE PENALTY

2nd offence – EXCLUSION

Reconnaissance cars must conform to the following criteria:

- Only standard cars may be used.
- Competitors will be permitted **2 observation runs over the stages** ~ Road books, the 2 Timed runs may be recorded.
- The engine must be a series production engine (complying with the Group N regulations).
- No advertising may be carried on the car.
- The organisers have the power not to allow the use of any particular car.
- A competitor who practices, reconnoitres or otherwise examines a Special Stage or uses any other person(s) to do so on his/her behalf, outside of the dates and times stated above, will be excluded from the competition without refund and reported to the Motorsport UK / Motorsport Ireland – **THIS WILL BE STRICTLY ENFORCED.**

Please do not risk the future of closed road rallying by Recceing inconsiderately, remember these roads are open to the public and respect other road users and the local residents who are accommodating your sport.

In all circumstances, competitors are advised that the organisers accept no liability or responsibility in the use of the subjective route notes.

Special requirements

Competitors wishing to carry on board camera(s) during the event must declare to the Chief Scrutineer on arrival at scrutineering and complete the necessary documentation (Motorsport UK GR R48.10.10). Cars must be presented at scrutineering with the camera(s) fitted. Cameras that are affixed to the outside of the vehicle by temporary fixing devices including, but not limited to, suction devices, must also be attached to a permanent bracket or non-removable bodywork by means of a restraining strap. Cameras that extend outside the extent of the door mirrors when viewed from the front of the vehicle are prohibited.

The organisers may request the removal of video footage from on board cameras deemed to be offensive or of a sensitive nature should it be posted on the internet or social media websites. Any competitor who does not comply with this request may be reported to Motorsport UK for further action.

10. Timing/Timecards

For all sections of the event timing is set to BBC/BT Timing, and will be timed using Digital clocks to 1/10th of a second from standing start to flying finish on Roads closed to the Public. (Motorsport UK GR R31.1 – R31.2.1) as per Motorsport UK Yearbook 2024)

The starting for special stages will be given by means of “Start lights” which will work as follows:

30 seconds	RED light will be displayed
15 Seconds	RED and AMBER lights will be displayed
10 Seconds	RED light will go out
5 Seconds	AMBER countdown 5,4,3,2,1
START TIME	GREEN light goes ON

The finish time will be displayed on screen in hrs, mins, seconds and 10ths of a second with your car number. It is up to the navigator to record his/her time on their timecard. The definitive checks will be the stored times in the clock and the marshals check sheet.

All controls will open 15 minutes before the Due Time of the first car and close 15 minutes after the Due Time of the last competitor still running (Motorsport UK GR R30.1), having taken into account any delays.

In the event of unforeseen circumstances arising affecting the Road Closing Order, the organisers are seeking approval from Motorsport UK to use 30 second starts.

Missing a control or stage

Crews are reminded that it is their responsibility to ensure their car is SAFE to compete. This includes after an incident, continuing to compete in a vehicle unfit to drive on the public highway will be considered bringing the sport into disrepute.

Crews missing a Control or Special Stage will be penalised in accordance with Motorsport UK GR R32.2(a)(i) and will incur the appropriate penalty.

Red Flag Procedure

Competitors are reminded to read and understand the Red Flag Procedure as prescribed in Motorsport UK GR R25.6.4.

“On passing a Red Flag displayed by a marshal wearing a marshals’ tabard, the driver MUST immediately and significantly reduce speed as well as being prepared to stop at any time; at no time must they overtake any safety vehicle they encounter on the special stage route. The driver must then follow the instructions of any marshals and/or stage safety personnel and maintain this reduced speed until leaving the special stage.

Failure to comply with this rule will incur a penalty at the discretion of the Clerk of the Course.

11. Penalties

Each special stage will have a Bogey Time set at 80mph for sealed surfaces which will be indicated on the Time Cards

Competitors will receive penalties on Special Stages as follows:

- Under Bogey – Bogey Time
- Over Bogey – Actual Time Taken

- Stage Maximum
- Over Stage Maximum – Stage Maximum

Competitors will start with zero time penalties. The results will be established by adding the times taken during the special stages and the time penalties incurred on the road sections together with all other penalties expressed in time. The competitor with the lowest total will be the winner and so on. (Motorsport UK GR R40.1.1).

If there is a tie, the competitor who accomplished the best time for the first special stage will be declared the winner. If this is not sufficient to be able to decide between the tied competitors, the times of the second, third, fourth etc. special stages will be taken into consideration. (Motorsport UK GR R40.1.2).

21 Special Stages & road sections

21.1 Achieving a time which is less than the minimum time stated on the time card - MINIMUM TIME FOR STAGE.

21.2 Achieving a time which is greater than the maximum time stated on the time card – MAXIMUM TIME FOR STAGE plus 10 seconds penalty per minute over the stage maximum.

21.3 Achieving a time which is between 1 and 2 above – ACTUAL TIME IN MINUTES, SECONDS (AND TENTHS OF A SECOND).

21.4 Failure to attempt a special stage = Stage Maximum PLUS 10 minutes for each stage missed.

21.5 Failure to follow specified stage route = MAXIMUM TIME FOR STAGE.

21.6 Failure to start a special stage when instructed = 10 MINUTES.

21.7 Any competitor or any person acting on behalf of a competitor found on any stage, after the publication of the regulations, until the finish of the event will be excluded. The person or persons will be reported to Motorsport UK /MSI for possible further penalties. This excludes any period of recce allowed by the organisers.

21.8 Reporting at any Control after due time = 10 SECONDS PER MINUTE.

21.9 Reporting at any Control before due time = 20 SECONDS PER MINUTE.

21.10 Not reporting at a Control = EXCLUSION.

21.11 Wrong approach or departure at a Control = 10 MINUTES.

21.12 Servicing outside designated service area(s) = EXCLUSION.

21.13 Reporting at a Control, 15 or more minutes after due time = EXCLUSION.

21.14

21.15 Failure by a crewmember to fasten their Crash Helmets properly = EXCLUSION.

21.16 Failure to produce or surrender any Time Cards on request = EXCLUSION.

21.17 Misconduct by any member of a service crew or competing car = EXCLUSION.

21.18 Making a false start on a stage – ONE MINUTE.

21.19 Breach of Regulation – R5.4, R15.1.2, or R25. = EXCLUSION.

21.20 Breach of statutory requirement concerning the driving of a motor vehicle = EXCLUSION.

21.21 Receiving assistance contrary to R38.1.1 – R39.3.3 = EXCLUSION.

21.22 Failure to report at a specified day for scrutiny = EXCLUSION.

21.23 Not complying with a requirement of the road book – 10 MINUTES.

21.24 Excessive speed or conduct likely to bring motor sport into disrepute – 1st offence - 10 minutes – 2nd offence - EXCLUSION.

21.25 Excessive noise in breach of MUK limits = EXCLUSION.

21.26 Refuelling a competing vehicle in breach of the event regulations =

EXCLUSION.

21.27 Use of tyre heating devices – Penalties for breach of this regulation will be left to the discretion of the Clerk of the Course which may go as far as exclusion

21.28 Not obeying the instructions of an official – 5 Minutes

21.29 Refuelling without the permission of the Clerk of the Course – 5 minutes

A copy of the Supplementary and any other relevant regulations will be posted on the Official Notice Board.

22 Stage Starts will be done by means of a flag or other type of signal. After the signal the competitor will accelerate into the stage. All special stages have a flying finish. After crossing the finishing line the competitor will stop at the timekeepers control and have his or her time recorded. Instructions on how to use the beam timing system will be provided in Final Instructions 1.

The penalties in “Motorsport UK GR R32.2. – Chart 32.2 – Penalties” apply unless specifically modified in these SRs.

11. Driving Standards Observers/Judges of Fact

Driving Standards Observer’s/Judges of Fact will be named (on the notice board) for the event to be on duty thorough the recce and on the day of rally. Their report may result in the imposition of a penalty for excess speed or bringing the sport into disrepute shall also be reported to the Stewards of the Meeting (Motorsport UK GR R32.2 Chart 32.2 Penalties (I)).

Should any special stage be cancelled during the event, or deleted from the results after the event, only the stage penalties will be deleted. Unless an official bulletin has been issued to the contrary, the cancelled stage must be traversed within the stage maximum time, and will in every other respect be treated as a road section.

All start officials on all special stages are appointed Judges of Fact for false starts.

The organisers may appoint Driving Standards Observers in accordance with Motorsport UK GR G11.1 – G11.2 and Motorsport UK GR R24.8

Traffic Laws

Throughout the entire event, the crews must observe the traffic laws of Northern Ireland with particular reference to erratic driving prior to entering a special stage (e.g. tyre warming/scrubbing). The PSNI will strictly enforce this regulation, which may go as far as prosecution.

Damage Declaration

Competitors will be required to complete a declaration that they have/have not been involved in any incident resulting in damage to private property or injury to persons or animals or alternatively giving details of any such incident where damage or injury has occurred (Motorsport UK GR R40.1.4). Information given will not incur a penalty, but failure to disclose details of any such incident, or failure to hand in a duly completed form will be penalised in accordance with Motorsport UK GR R32.2 Chart 32.2 Penalties (p) and may be reported to Motorsport UK for further disciplinary action.

This declaration must left in the in box provided at the finish ramp. If a competitor fails to reach the finish ramp the declaration must be completed and returned to the Rally Office or to the Secretary within 72 hours of the finish of the event (Motorsport UK GR R40.1.4).

14. PROTESTS AND APPEALS

Protests and appeals are in accordance with Motorsport UK GRs.

- Provisional results will be published as soon as possible after the event finish.
- Competitors shall ensure that they and their cars are available for inspection should a protest be submitted in accordance with Motorsport UK GR C5.2.2. If the protested vehicle is not available for inspection the competitor may be penalised in accordance with Motorsport UK GR C3.2.

CAR TRACKING

The rally will operate a mandatory GPS safety tracking system that will enable the speed and position of each competing vehicle to be monitored and logged. Before the start, all cars will be fitted with a tracking device that will remain active throughout the event. This must be retained in the car until the finish where it will be removed by the system providers. If a competitor retires during the event, the device must be returned with the damage declaration form. Failure to return the equipment will result in the driver being invoiced for its replacement.

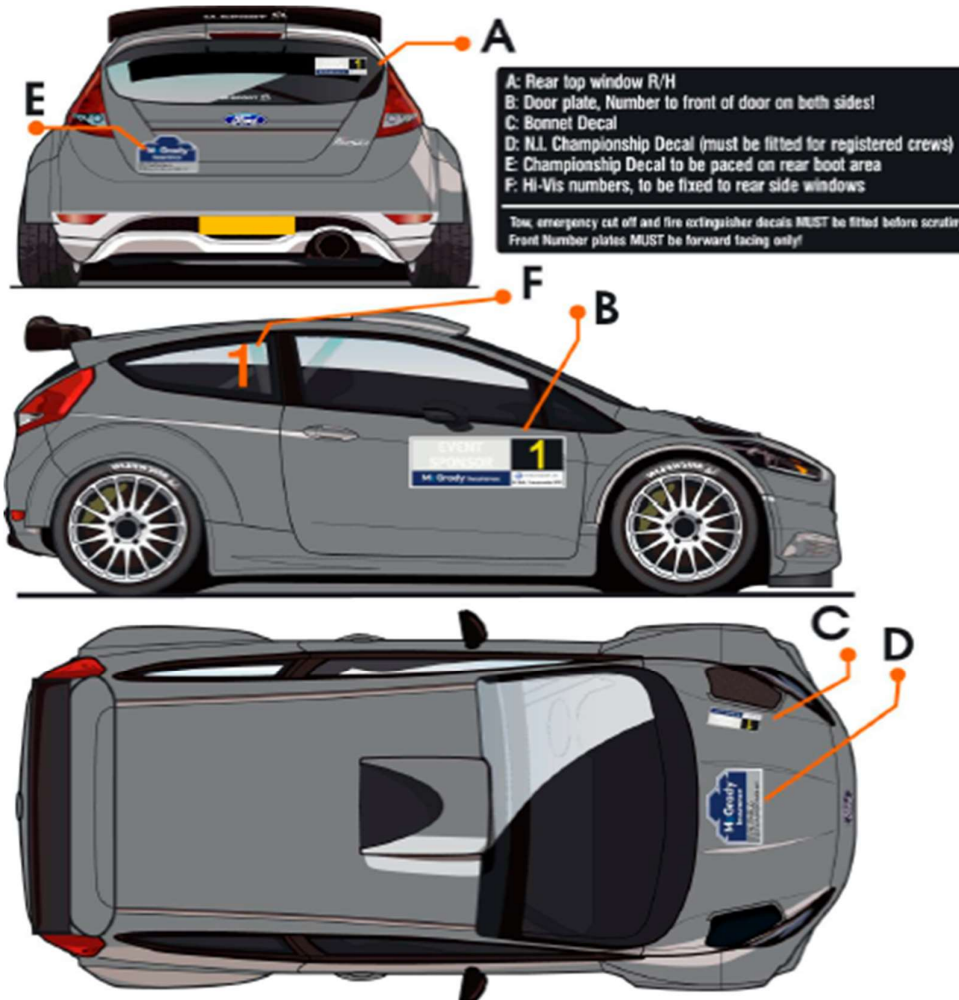
