and after hearing of Entrant / Driver the Stewards came to the following DECISION :

Disgualification from the weekend Fine of 15.000,00 EURO

Side decision: Due to the manipulation of the race result by an orchestrated collision the stewards decided to change the race result. In order to find a fair result for the classification of the race the classification of the penultimate lap will be the final classification.

The driver and entrant will also reported to their national ASN (KNAF)

Offence : Violation of DMSB Karting Regulations Art. B.4.2.g and ISC Art. 12.2.1.L

Punishment in application of Art. 11.9.3.j and 12.4.1.c and m FIA International Sporting Code Applied Article :

The driver #69 started from the 7th position in the race and drove unusual slow in the first two laps and Reason : lost many positions, after that he continued with racing speed in the end of the racing field. In the last two laps of the race he reduced the speed again and waited for the driver #6. In the last lap (21) of the race at MP4. #6 startet to overlap #69. During that manoeuver he caused a avoidable collision with #6. The driver #6 had to stop the race because of a damaged kart and a injuried leg. This manoeuver changed the result in the outcoming of championship, that #6 lost the first place and the brother of #69 won the title. The steward come to the descision, that this manoeuver was orchestrated to manilpulate the result of the championship.

Entrants are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with article 15 of the FIA Int. Sporting Code, CIK-FIA General Prescriptions and art. 28 of DMSB General Event Regulations, within the applicable time limit.
