The Stewards, having received the report N° 2 from the Technical Delegate (document n° 6.4), having examined attached report from the GPS provider, having considered the following matter, determine the following:

Fact: The crew of car #15 did not pass the tyre marking zone and did not follow the road direction diagrams shown in the roadbook

Offence: Breach of 2026 FIA Regional Rally Sporting Regulations (RRSR) Art.13.8. and 19.2

Decision: **To impose a Time Penalty of 3 minutes on Competitor Car #15, to be applied at TC4.**

Reason: After studying the tracking data provided by the CoC a hearing was held on Saturday, 18th April 2026 at 11:00
The Steward's heard the driver, codriver and the team representative, Mr. Kristo Kraag.

The crew were shown the evidence from the tracking device, which outlined the infringement.

They admitted that they did not follow the road direction diagrams shown on page 61, box 3 of the Roadbook.

The crew recognized the mistake that they made and apologized for their mistake. They referred they were thinking in advance and forgot to pass the tyre marking zone after refueling.

The Stewards accepted that this was an unintentional mistake by the crew.

For checking the marking of tyres the crew must pass through the tyre marking zone and has to stop its car and wait for the instructions of the scrutineers and/or marshal.

Since car #15 did not pass through this zone and stopped, it is a breach of regulations.

This decision is based on the FIA 2026 International Sporting Code Art. 11.7.3.a, 11.7.3.f and 12.4.1.h.

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2026 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
