All Competitors / crew members

The Stewards, having received a report from the Clerk of the Course, summoned the above crew members as well as a Competitor's representative, have considered the following matter and determine the following:

Facts The crew of car 22 entered SS 12 Päijälä at 09:03 on 30 July 2024, i.e. 12 minutes

before the stage opened for Recce Group A.

Offence Breach of Articles 35.4.1 and 35.4.2 of the 2024 FIA WRC Sporting Regulations

Breach of Article 9.2.1 of the Supplementary Regulations of SECTO RALLY FINLAND

Decision Driver NIKOLAY GRYAZIN and Co-driver KONSTANTIN ALEKSANDROV shall be

jointly and severally liable to pay a fine of € 300.

In accordance with Art. 12.8 of the 2024 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail

Suspension during the period a fine remains unpaid.

Reason A hearing was held on Thursday, 1 August 2024 at 17:25 hrs in the presence of the

Driver Mr. NIKOLAY GRYAZIN, Co-Driver KONSTANTIN ALEKSANDROV and Team

Representative Ms. CORALIE BARBASSAT.

The Stewards heard the explanations of the co-driver, who admitted his mistake of not adhering to the reconnaissance time schedule and explained it was not done on

purpose.

However, the Stewards advised that such mistakes can be detrimental to the support of motorsport among the government, community officials and local residents, who


support the competition, and expect that all participants will follow the rules.
