The Stewards, having received a report from Clerk of the Course (Doc. 3.7) including GPS tracking system information, have considered the following matter, determine the following:

**Driver and car No:** #303 ALOBAIDAN Mashael / GARCIA CHAVEZ Hector

**Competitor:** SOUTH RACING CAN-AM

**Fact:** On SS 2 Drawsko Pomorskie the Crew left the prescribed track after km 2,43 (at Road Book – page 19) and re-joined at km 7,24 (at Road Book – page 22) and left the prescribed track after km 64,84 (at Road Book – page 44) and re-joined at km 68,89 (at Road Book – page 46).

Finally, the Crew did not drive the distance of 8,86 km of the compulsory itinerary.

**Offence:** Breach of Article 14.2.1 of the 2022 FIA Cross-Country Rally Sporting Regulations.

**Decision:** Time penalty 15 minutes added to his time for SS 2 Drawsko Pomorskie

**Reason:** Art. 14.2.1 of the 2022 FIA Cross-Country Rally Sporting Regulations provides that the compulsory itinerary of the Rally (Baja) is defined in the Road Book by the road direction diagrams and between the road direction diagrams, by the defined road/track if it exists. In the present case, the crew not only violated that requirement of the regulations, but shortened the distance of the SS very significantly by more than 8,86 km.


The Stewards have decided to impose a time penalty as follows:


1. 2 minutes per WPP (2 WPP missed);
2. 11 minutes for missing route

The Decision is based on the FIA 2022 International Sporting Code Art. 11.9.1; Art. 11.9.3.a, Art. 11.9.3.f, Art. 12.4.1.h.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
