During the ride, the passengers have to cope with extreme strains in terms of:
- · Acceleration, braking and cornering
- Bumps
- Vibrations
- Temperatures
- Noises
- Smells

- 2. Herewith the passenger is instructed that persons suffering from any of the physical complaints or diseases mentioned by way of example below should not be exposed to the strains mentioned above.
- Diseases/illnesses that prohibit them from driving on normal roads due to road traffic regulations
- Heart and circulatory weaknesses
- Periods of convalescence after a heart attack and stroke
- Cardiac arrhythmia
- Disorders of the sense of balance and hearing
- Ailments of the spine
- Diabetes with a tendency to low blood sugar
- A tendency to a state of anxiety or panic

If the passenger feels unwell, the driver must be notified at once and the co-drive has to be stopped immediately.

- 3. Having taken all this in account, the passenger declares, unless prohibited by law, to waive any claim for any kind of injury or damage occurring in conjunction with the co-drive except for those injuries or damages that are caused by a premeditated or gross negligen act or omission. This waiver takes into account the actions of the parties mentioned below:
- the team, driver, car manufacturer, owner and keeper of the vehicle concerned
- the organiser, officials, marshals and the owners of the roads being used
- authorities, race services and all other persons involved in the organization of the event
- road maintenance authorities, in case damage is caused due to the condition of the roads including additional materials used during the event
- ADAC and its regional clubs, Slowly Sideways
- representatives of all legal and natural persons mentioned above, authorities, corporations etc. The waiver is also valid for other participants, their assistants, the owners, keepers, drivers and manufacturers of the other vehicles.

In the case of any dispute concerning the wording of this exclusion of liability and waiver, the German text shall be deemed to be the authoritative text.
